


REVISED ORDINANCE

ANALYSIS

This ordinance amends Title 6 - Salaries, of the Los Angeles County Code by:

- Adding and establishing the salary for three (3) employee classifications;
- Deleting two (2) non-represented classifications;
- Changing only the title of one (1) non-represented employee classification;
- Changing the title and salary of one (1) unclassified position;
- Amending Sections 6.78.350 (Department of Health Services – Additional information) to reflect Medical Staff Credentialing – Assignment bonus; and
- Adding, deleting, and/or changing certain classifications and numbers of ordinance positions in the departments of Agricultural Commissioner/Weights and Measures, Board of Supervisors, Health Services, and Sheriff.

ORDINANCE NO. 2010-0034

An ordinance amending Title 6 – Salaries, of the Los Angeles County Code relating to the addition, deletion, and/or changing of certain classifications and number of ordinance positions in various departments to implement the findings of classification studies.

T. Medical Staff Credentialing – Assignment bonus.

1. The three persons assigned to oversee the medical staff credentialing activities at LAC+USC Medical Center (Medical Staff Coordinator – Item No. 0928), Martin Luther King, Jr. Multi-Service Ambulatory Care Center (MLK-MACC – Credentialing Specialist, Item No. 0927), and the High Desert MACC (Credentialing Specialist - Item No. 0927) shall be entitled to receive additional compensation at the rate of 22 levels (5.5%) higher than that established for their respective classifications. The rates established by this provision shall constitute a base rate and shall cease when these assignments are vacated.

2. The person employed as a Credentialing Specialist (Item No. 0927) and assigned to serve on a permanent basis as the lead assistant to the Medical Staff Coordinator (Item No. 0928) at LAC+USC Medical Center shall be entitled to receive additional compensation at the rate of 22 levels (5.5%) higher than that established for this classification. The rate established by this provision shall constitute a base rate and shall cease when this assignment is vacated.
