MANDATED AND NON-MANDATED COUNTY SERVICES

On January 11, 2011 your Board, on a motion by Supervisor Antonovich, directed the Chief Executive Officer to report back with a list of mandated and non-mandated programs that are currently being provided, that may be cut, and how those cuts would impact services in the County. Given the broad range of services provided by the County, we are focusing our report on the net County cost (NCC) portion of the County budget only.

As illustrated on Attachment I, the County budget can be divided into three (3) components, Fixed, Non-Flexible and Flexible Costs.

Fixed Costs - \$17.7 Billion

The fixed cost component, which comprises 73.1 percent of the budget, represents those costs or programs that are not discretionary in nature and the County does not have control over how these programs are funded. Costs for these programs do not require NCC and are financed entirely with revenues from outside the County. Since these program costs do not impact County discretionary revenues, we are not reviewing programs funded in this portion of the budget.

Non-Flexible Costs - \$2.8 Billion

The non-flexible portion of the County's budget, which reflects 11.6 percent of the budget, is funded with County discretionary revenues. This component of the County budget generally reflects Maintenance of Effort (MOE) requirements, mandatory services that the County is responsible for or contractual obligations that the County has entered.

Flexible Costs - \$3.7 Billion

The flexible portion of the County's budget, which comprises 15.3 percent of the budget, is also funded with County discretionary revenues. This portion of the budget generally reflects the budget priorities of your Board.

Attachment II provides your Board with a listing of County departments, how much of their budget is funded with NCC by program and whether or not the program is either mandated or discretionary (non-mandated) by federal, State, or local laws. We have excluded from our report those budget units, such as capital projects and extraordinary maintenance, that generally are one-time costs in nature.
