ACCEPT A GRANT AWARD FROM THE CALIFORNIA EMERGENCY
MANAGEMENT AGENCY FOR FISCAL YEAR 2011-12 CHILDREN EXPOSED
TO DOMESTIC VIOLENCE SPECIALIZED RESPONSE PROGRAM
(FIFTH DISTRICT) (3 VOTES)

### SUBJECT

Request Board approval for the Sheriff of Los Angeles County (County) to accept a grant award in the amount of \$200,000 without a required match for the Children Exposed to Domestic Violence Specialized Response (CEDV) Program from the California Emergency Management Agency (CalEMA) for the grant period from October 1, 2011, to September 30, 2012.

#### IT IS RECOMMENDED THAT YOUR BOARD:

- 1. Approve and authorize the Sheriff to accept a grant in the amount of \$200,000 without a required match from CalEMA for the CEDV Program for the grant period from October 1, 2011, to September 30, 2012.
- 2. Instruct the Mayor of the Board to execute and provide a wet signature on Attachment I, Certification of Assurance of Compliance, as required by CalEMA, certify compliance with all grant requirements and to authorize the Sheriff to act as an agent of the County.
- 3. Delegate authority to the Sheriff to execute and submit all grant documents, including applications, agreements, augmentations, extensions, and renewals.

### PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

This grant will be used to maintain the Los Angeles County Sheriff's Department's (Department) Palmdale Sheriff's Station's CEDV Program that will identify and respond to the needs of children

exposed to domestic violence within the station's service area. Researchers have identified the varying effects of domestic violence on children indicating its results in behavioral, emotional, and cognitive developmental problems.

Palmdale Sheriff's Station's CEDV Program will participate in a collaborative partnership with the Department of Children and Family Services and the Antelope Valley Domestic Violence Council-Valley Oasis Shelter to identify and reduce the trauma of these children by providing services such as protection, shelter, counseling, and/or medical assistance.

### <u>Implementation of Strategic Plan Goals</u>

This program is consistent with the County's Strategic Plan, Goal 1, Operational Effectiveness; Goal 2, Children, Family and Adult Well-Being; and Goal 5, Public Safety, by effectively and efficiently providing public service and strengthening the safety and well-being of children exposed to domestic violence.

### FISCAL IMPACT/FINANCING

This is the third year of the funding cycle for this program. The term of the Grant Award Agreement is for a period of one-year from October 1, 2011, to September 30, 2012.

The Fiscal Year (FY) 2011-12 will be funded in the amount of \$200,000. Funds in the amount of \$138,950 for Salary and Employee Benefits for one Department full-time deputy; \$31,874 for one Department of Children and Family Services part-time children's social worker; \$25,848 for one part-time children's advocate worker; and a total of \$3,328 for office supplies, training, and other costs. There is no match required for this program.

Funding for this program has been included in the Department's FY 2011-12 budget.

### FACTS AND PROVISIONS/LEGAL REQUIREMENTS

This is the third year of the funding cycle for the program. The Certification of Assurance of Compliance requires, among other things, that any liability arising out of the performance of the grant, including civil court actions for damages, shall be the responsibility of the County. The State of California and CalEMA disclaim responsibility for any such liability. Also, grant funds from CalEMA shall not be used to supplant expenditures controlled by the County.

This Board letter has been reviewed and Attachment I has been approved as to form by County Counsel.

### <u>IMPACT ON CURRENT SERVICES (OR PROJECTS)</u>

The District Attorney and the Alternate Public Defender's Office have determined that this program will not have an impact on their respective departments; however, the Public Defender's Office has responded that this program will have minimal impact on their department.

### III. Drug-Free Workplace Act of 1990 – (Recipient Handbook, Section 2152)

### VIII. Special Conditions for Grand Awards with Children's Justice Act Fund

Federal grant funds shall not be used to support inherently religious activities such as religious instruction, worship, or proselytization. Therefore, organizations must take steps to separate, in time or location, their inherently religious activities from the services funded under this program. Federal grant funds provided under this award may not be used by the recipient to support lobbying activities in influence proposed or pending Federal or State legislation or appropriations. This prohibition is related to the use of Federal grant funds and is not intended to affect an individual's right or that of any organization, to petition Congress or any other level of Government, through the use of other resources. (See 45 CFR Part 93.)

In accordance with Public Law 103-333, the "Department of Labor, Health and Human Services, and Education, and Related Agencies Appropriations Act of 1995," the following provisions are applicable to this grant award:

Section 507: "Purchase of American-Made Equipment and Products – It is the sense of the Congress that, to the greatest extent practicable, all equipment and products purchased with funds made available in this Act should be American-made."

In accordance with Part C of Public Law 103-227, the "Pro-Children Act of 1994," smoking may not be permitted in any portion of any indoor facility owned or regularly used for the provision of health, day are, education, or library services to children under the age of 18, if the services are funded by Federal programs wither directly or through State or local governments. Federal programs include grants, cooperative agreements, loans and loan guarantees, and contracts. The law does not apply to children's services provided in private residences, facilities funded solely by Medicare or Medicaid funds, and portions or facilities and used for inpatient drug and alcohol treatment.

All appropriate documentation must be maintained on file by the project and available for Cal EMA or public scrutiny upon request. Failure to comply with these requirements may result in suspension of payments under the grant or termination of the grant or both and the Recipient may be ineligible for award of any future grants if the Cal EMA determines that any of the following has occurred:

(1) the Recipient has made false certification, or (2) violates the certification by failing to carry out the requirements as noted above.
