**FISH AND GAME PROPAGATION FUND GRANT AWARDS  
(FIRST SUPERVISORIAL DISTRICT)

**SUBJECT**

Recommendation to approve a grant request using the Fish and Game Commission Propagation Fund for the establishment of a Junior Fishing Club at the Whittier Narrows Regional Recreation Area.

**IT IS RECOMMENDED THAT YOUR BOARD:**

Approve a Fish and Game Propagation Fund Grant request in the amount of \$2,500 to assist in funding the establishment of a Junior Fishing Club at the Whittier Narrows Regional Recreation Area – Legg Lake, 750 S. Santa Anita Avenue, in the City of South El Monte.

**PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION**

The Commission has determined that the grant request will promote education, conservation and the propagation of fish and game thus benefiting Los Angeles County and the State of California.

At its meeting held July 14, 2011, the Commission approved the enclosed grant request from the Los Angeles County Department of Parks and Recreation requesting a Fish and Game Propagation Grant request for the purpose of providing fishing equipment for the newly formed Junior Fishing Club at the Whittier Narrows Regional Recreational Area.

The Program is designed to provide a family-oriented recreational activity to residents of the County

while offering environmental education, and enhancing the interest of fishing in the local youth and their families.

The Junior Fishing Club will be held in conjunction with the Dan Hernandez Youth Foundation, and funding will be utilized to cover program expenses for the period of July 18, 2011 through December 2011.

### **Implementation of Strategic Plan Goals**

Providing funding to assist in the establishment of this Junior Fishing Club is consistent with the County's Strategic Plan Goal No. 3 (Community and Municipal Services). In addition to enhancing the community's knowledge and understanding of conservation and the propagation of fish and game, the Program will provide a safe and healthy environment increasing accessibility to County cultural, recreational and lifelong learning facilities and programs.

### **FISCAL IMPACT/FINANCING**

There is no impact on the General Fund. The approved expenditure will be charged to the Fish and Game Propagation Fund, which has sufficient funds to cover the cost.

The Los Angeles County Fish and Game Propagation Fund is financed from a percentage of penalty assessments collected relating to fish and game code violations in Los Angeles County.

### **FACTS AND PROVISIONS/LEGAL REQUIREMENTS**

Section 13100 of the Fish and Game Code establishes guidelines for the expenditure of fines levied for fish and game code violations. It includes public education relating to the scientific principles of fish and wildlife conservation, consisting of supervised formal instruction carried out pursuant to a planned curriculum and aids in education such as literature, audio and video recordings, training models, and nature study facilities.

### **IMPACT ON CURRENT SERVICES (OR PROJECTS)**

This Board action enhances the education, conservation and the propagation of fish and game thus benefiting Los Angeles County and the State of California.

### One Page Project Summary

The County of Los Angeles Department of Parks and Recreation, Whittier Narrows Recreation Area, is requesting \$2,500.00, in funding from the County of Los Angeles Fish and Game Commission for the purpose of providing Dan Hernandez Youth Foundation Junior Fishing Club at Whittier Narrows Recreation Area. The funding will be utilized from June 18, 2011 to December 2011. The site is located at:

Funding will be used to provide fishing equipment for the newly formed Junior Fishing Club at Whittier Narrows Recreation Area. This program will be held in conjunction with the Dan Hernandez Youth Foundation. The program is designed to provide a family oriented recreational activity to residents of Los Angeles County while offering environmental education and enhancing the interest of fishing in the local youth and their families.

In the past, the Department of Fish and Game has provided fishing opportunities at County operated lakes, offering a valuable recreational activity to local communities surrounding the park. County residents, both young and old and of varying household income levels, partake in the enjoyable and relaxing environment that fishing has to offer.

Funding through the Fish and Game Commission will allow Whittier Narrows to offer a youth fishing program, emphasizing the education and fun of fishing to youth and their families. ## **BACKGROUND ON APPLICANT'S ORGANIZATION**

### Purpose and Goals

The County of Los Angeles Department of Parks and Recreation, Whittier Narrows Recreation Area's mission is to meet the diverse leisure needs and recreational interests of more than a million residents of Los Angeles County that use the 1,400 acres of Whittier Narrows annually. This unique facility is comprised of many special interest areas. A 419 acre natural area which is a protected wildlife preserve with two lakes and 1,100 acres of open space for sporting activities, picnics and fishing.

### Brief Summary of Current Activities

Whittier Narrows currently has no Junior Fishing Club but, provides three fishing derbies per year working in conjunction with the education department of California State Fish and Game. This facility offers an enjoyable opportunity to residents of all ages to participate in a variety of activities. The current level of service offered at the facility provides the community open space to enjoy family picnics, fishing, riding, walking and equestrian trails. Whittier Narrows also provides low cost community special events, organized sports programs, and hobby activities throughout the year.

### Geographic Area Served

The County parks and programs are open to everyone without regard to race, ethnicity, income level or place of residence. Local parks are generally considered to have a service radius of ½ to 2 miles, while regional parks are not generally considered to have a service radius and thus can draw participants from areas that are remote from the park.

The Department's vast resources include more than 65,000 acres of public open space and recreational areas spread throughout the 4,083 square miles of the County and located in various communities from Rancho Palos Verdes to East Los Angeles to the Antelope Valley that differ greatly in ethnicity, income levels, population densities and many other socioeconomic characteristics.

Major Sources and Dollar Amounts of Corporate, Foundation and Government Support During Current and Past Fiscal Year.

Each year, Whittier Narrows Recreation Area maintains its park facilities through a combination of Department General Fund moneys, user fees, donations, sponsorships, grants and endowments.

Low cost community based events are dependent on sponsorships and donations to enable the facility to offer these events to the residents. There is no Department funding for the community-based recreational programs such as the fishing events.

One of this Facility's main objective is to seek additional funding to enhance community programming at Whittier Narrows Recreation Area and to continue providing inner-city fishing to the public.

## **PROJECT INFORMATION**

### Statement of Justification of Need

In addition to recreational services provided at low or no cost to the patrons, this facility offers the public valuable learning opportunities by providing fishing clinics, free rod and reel loans, free bait, and volunteers to assist the youth in learning fishing techniques and answering any questions that the local youth might have about the catch and release practice, identification of types of fish, and any other questions they may have to enhance their enjoyment of fishing. Legg Lake is located in a urban setting, located many miles from any other public fresh or ocean fishing facilities. Whittier Narrows, Legg Lake is one of the few locations that provide an opportunity for Fishing to inner-city youth. Hence, offering a newly formed Junior Fishing Club at Whittier Narrows Recreation Area would allow a comprehensive growth to all of the Whittier Narrows fishing programs and activities.

### Statement and Purpose of Goals

A Junior Fishing Club at County parks allows this Department to offer an additional recreational activity to the residents of Los Angeles County. Family orientated Fishing events, youth fishing events, and recreational fishing give urban dwellers the opportunity to experience the "rural" sport of fishing, while allowing the Department to control the quality and quantity of fish available for public fishing activities. Moreover, providing this additional service encourage usage of Whittier Narrows lake facilities, thereby enhancing the attractiveness of this facility's amenities and preventing the unauthorized dumping of debris, waste materials and non-approved varieties of fish into the lakes.

### Action Plan to Meet Objectives

This program funding, if granted by the Fish and Game Commission, shall enhance and continue this facilities' efforts to provide increased the fish population at Legg Lake.

By obtaining additional funding, Whittier Narrows Recreation Area will work with the Department of Fish and Game Education in providing a low cost, safe, educational family-oriented Junior Fishing Club emphasizing the joy of Fishing.

Statement of How the Objectives Advance the Propagation and Protection of Fish and Wildlife

Through collaboration with the Daniela Hernandez Youth Foundation, Whittier Narrows will be enhancing the education of propagation and protection of fish and wildlife through the Junior Fishing Club operated throughout the year. Only through education can we ensure the proper respect for the future of wildlife and fish. Moreover, by providing the Junior Fishing Club with proper fishing equipment, we contribute to the balance and maintenance of the fish population at Legg Lake.

Project Budget and Timetable

This is the first year of the fishing program. Therefore, the fees that will be charged per meeting will be charged by the operational organization (Daniel Hernandez Youth Organization) and will be past on to cover the amount of bait, tackle (for pole loan), and indirect costs incurred from the program that have not been determined. Any remaining costs are covered by donations and sponsorships to the operational organization (Daniel Hernandez Youth Foundation). One of the most valuable cost savings is the continued recruitment and dedication of volunteers that provide the technical support for our Junior Fishing Club program.

Sources of Other Support for Project

Currently, we are seeking additional sponsors. Support letters have been sent to major sources to subsidize the program. In addition, we will continue to solicit donations from various groups, businesses, and private sources to off set costs to assure that this valuable program continues for our youth and their families. However, we currently are also working with the Dan Hernandez Youth Foundation to primarily operate the program on a monthly basis.

### Current Status of Project

Currently, a special recreation fund has been set up to assist in funding of recreational programming. However, funding is not sufficient enough to cover total expenses and additional donations, both in-kind and monetary are being sought

### Cash Flow Analysis of the Expenditure of Project Funds

Budget is based on the total cost of expenses from previous all fishing programs/ events held at Whittier Narrows Regional Area in 2010 and utilizing the north lake, due to the decreased amount of participants from previous years. (See attached budget)

### Proposed Method of Evaluating Results

The number of participants will be the major measurement of success. In addition, a registration form to be filled out by participants which will enable in monitoring age group and number of participants, and first time participants and registrants. Dollar value of in-kind materials, and volunteer time will be an indicator of money saved. Confirmation reports from this Department's field staff, will be used in addition to paid invoices to the fishing equipment vendors, verifying that the Fish and Game Commissions funds are used for the purchase of the additional fishing equipment stocked towards the utilization of the Junior Fishing Club as stated in the purchase for the Junior Fishing Club operations at Whittier Narrows Recreation Area.
