SUBJECT

Recommendation to appoint, set the salary of and approve relocation expenses for Jerry E. Powers to serve as Chief Probation Officer of the County of Los Angeles.

IT IS RECOMMENDED THAT YOUR BOARD:

1. Approve the Chief Executive Officer's recommendation to appoint Jerry E. Powers to the position of Chief Probation Officer effective December 5, 2011 at an annual salary of \$255,000.
2. Approve reimbursement of up to \$25,000 for reasonable actual costs of relocating the family and personal residence of Mr. Powers.
3. Instruct the Chief Executive Officer to execute an at-will employment contract which is approved as to form by the County Counsel.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The purpose of the recommended actions is to appoint Jerry E. Powers as the Chief Probation Officer of the County of Los Angeles; to set a salary for Mr. Powers; and to authorize the payment of reasonable actual relocation expenses related to moving the family and personal residence of Mr. Powers to the Los Angeles County area through the services of a professional moving company.
