SUNSET REVIEW FOR THE LIBRARY COMMISSION (ALL SUPERVISORIAL DISTRICTS) (3 VOTES)

SUBJECT

Request to extend the sunset review date for the Library Commission.

IT IS RECOMMENDED THAT YOUR BOARD:

Extend the Library Commission's sunset review date to June 30, 2014.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The Library Commission (Commission) was established by the Board of Supervisors (Board) on December 3, 1996. The Board approved the most recent sunset review extension on June 15, 2004, which expired on January 31, 2007.

The Commission advises the Board and the County Librarian on matters of library policy, administration, operation and service, including the County Public Library's (Library) budget and Strategic Plan, and makes suggestions and recommendations with respect to any matters that have come to their attention relating to the County Public Library.

The Commission also obtains public input and provides information on the Library to the public.

FISCAL IMPACT/FINANCING

Commission members do not receive compensation. The Library estimates that they spend

approximately \$36,600 per year to support the Commission.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

The Commission has 20 members; two appointed by each Supervisor and ten appointed by a "City Selection Committee", comprised of mayors and city council members from cities in the County.

The Commission meets on a monthly basis. The Commission held 24 meetings between April 2007 and December 2009 (approximately 9 meetings a year), with an average attendance of 10.7 (54%) members. The Commission recognizes its low average attendance, and is actively working to improve attendance by meeting with Board and city representatives to encourage stronger participation from their appointed Commissioners, and emphasizing the importance of attending Commission meetings. Although the Commission's average attendance was low, the Commission successfully fulfilled its duties.

During this review period, the Commission's accomplishments included:

- Advising the Board on the importance of supporting public libraries during difficult economic times.
- Raising public awareness about the negative impact of State budget cuts on library funding, resulting in hundreds of citizens sending letters to State legislators to oppose library budget cuts.
- Advising the Library on spending priorities, such as maintaining library hours and programs, ensuring public access to computers and electronic databases, and purchasing new books.
- Participating in a focus group to provide input for the Library's Strategic Financial Plan, such as advising on what library services are valued the highest by the public.

SUBJECT: SUNSET REVIEW FOR THE LOS ANGELES COUNTY LIBRARY COMMISSION

RECOMMENDATION

The Audit Committee recommend to the Board of Supervisors (Board) to extend the Los Angeles County Library Commission's sunset review date to June 30, 2014.

BACKGROUND

The Board established the Los Angeles County Library Commission (Commission) on December 3, 1996. The Board approved the most recent sunset review date extension in June 2004.

The Commission advises the Board and the County Librarian on library policy, administration, operation and service, including the County Public Library's (Library) budget and Strategic Plan, and makes suggestions and recommendations on Library issues. The Commission also obtains public input and provides information on the Library to the public.

The Commission has 20 members, two appointed by each Supervisor, and ten appointed by a "City Selection Committee" (Committee), comprised of mayors and city council members from cities in the County. The Committee appoints ten of its members (two from each Supervisorial district) to represent cities served by the Library.

The Commission is supposed to meet monthly. Commission members do not receive compensation. The Library estimates that they spend approximately \$36,000 a year to support the Commission.

The stated mission is as set forth in the Board order establishing the Commission. <u>CONCUR.</u>

The Commission advises the Board and the County Librarian on library policy, administration, operation and service. The Commission brings the experience and knowledge of elected city officials and community representatives to library planning and budgeting, and unites the County Public Library (Library) to the cities it serves.

The Commission's mission appears to be **RELEVANT**.

Section 2. Meetings and Attendance. (Are required meetings held and is attendance satisfactory?)

The Commission is supposed to meet monthly. The Commission met 24 times between April 2007 and December 2009 (approximately nine times a year), with an average attendance of 10.7 (54%) members. The Commission recognizes its low average attendance, and is actively working to improve attendance by meeting with Board and City representatives to encourage stronger participation from their appointed Commissioners, and emphasizing the importance of attending Commission meetings. Although the Commission's average attendance was low, the Commission successfully fulfilled its duties.

The Commission's meeting frequency is **<u>SATISFACTORY</u>**, while the Commission's attendance is **<u>UNSATISFACTORY</u>**.
