PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Mr. Philip Browning has extensive experience in the social services field, including over 24 years with the State of Alabama. During his career with the State of Alabama, he was the Director of the Office of Fraud and Abuse as well as the Director of the Child Support Enforcement Division. Mr. Browning has also held the position of Director of the Child Support Enforcement Division for the District of Columbia – Office of the Corporation Counsel. During Mr. Browning's tenure with the County of Los Angeles he has served as the Director for the Child Support Services Department from July 25, 2001 through March 31, 2007, and as the Director for the Department of Public Social Services from April 1, 2007 through August 21, 2011. Since August 22, 2011 Mr. Browning has been serving as the Acting Director of Children and Family Services.

Given Mr. Browning's extensive executive-level management experience, it is recommended that your Board approve Mr. Browning's annual salary of \$255,000 effective February 16, 2012.

Approval of these recommendations will further the County of Los Angeles Strategic Plan Goal of Operational Effectiveness to enhance the quality and productivity of the County workforce.
