APPROVAL OF AMENDMENTS TO THE MEMORANDA OF UNDERSTANDING FOR BARGAINING UNITS 601–FIRE FIGHTERS; 602–SUPERVISING FIRE FIGHTERS; 611–PEACE OFFICERS; 612–SUPERVISORY PEACE OFFICERS; 613–PUBLIC DEFENDER INVESTIGATORS; 641–BEACH LIFEGUARDS; 642–SUPERVISORY BEACH LIFEGUARDS; AND 701–DEPUTY PROBATION OFFICERS (ALL DISTRICTS) (3-VOTES)

SUBJECT:

The Chief Executive Officer is recommending that the Board approve Amendments to several Memoranda of Understanding (MOU) to extend the terms and conditions of the MOUs for one year.

The current MOUs for Bargaining Units 601 – Fire Fighters; 602 – Supervising Fire Fighters; 641 – Beach Lifeguards; and 642 – Supervisory Beach Lifeguards, expired on December 31, 2011.

The current MOUs for Bargaining Units 611 – Peace Officers; 612 – Supervisor Peace Officers; 613 – Public Defender Investigators; and 701 – Deputy Probation Officers, expired on January 31, 2012.

IT IS RECOMMENDED THAT YOUR BOARD:

1. Approve Amendments to the Memoranda of Understanding (MOU) for the following Bargaining Units:

601 – Fire Fighters, Amendment No. 5;
602 – Fire Fighters, Amendment No. 5;

611 – Peace Officers, Amendment No. 6;
612 – Supervisory Peace Officers, Amendment No. 7;
613 – Public Defender Investigators, Amendment No. 4;
641 – Beach Lifeguards, Amendment No. 5;
642 – Supervisory Beach Lifeguards, Amendment No. 5; and
701 – Deputy Probation Officers, Amendment No. 6.

2. The current MOUs for Units 601–Fire Fighters; 602–Supervising Fire Fighters; 641–Beach Lifeguards; and 642–Supervisory Beach Lifeguards, expired on December 31, 2011. The Certified Employee Organizations, with the agreement of the Chief Executive Office, are requesting that the MOUs be extended one year to December 31, 2012.
3. The current MOUs for Units 611–Peace Officers; 612–Supervisory Peace Officers; 613–Public Defender Investigators; and 701–Deputy Probation Officers, expired January 31, 2012. The Certified Employee Organizations, with the agreement of the Chief Executive Office, are requesting that the MOUs be extended one year to January 31, 2013.

PURPOSE OF THE RECOMMENDED ACTION:

The purpose of the Amendments is as follows:

1. Extend the terms and conditions of the MOUs for one year;
2. Provide for the continuation of salaries;
3. Provide for the continuation of certain special pay practices relating to:
 - Uniform and/or clothing allowance;
 - Sick leave accrual exchange (buy back); and
 - The Wellness/Fitness for Life Program for Units 601–Fire Fighters; 602–Supervising Fire Fighters; 641–Beach Lifeguards; and 642–Supervisory Beach Life Guards.

IMPLEMENTATION OF STRATEGIC PLAN GOALS

The recommended action promotes fiscal prudence and service excellence between the County of Los Angeles and the Certified Employee Organizations; thereby providing more effective, efficient, and comprehensive services to Los Angeles County.

FISCAL IMPACT/FINANCING

There will be no new costs associated with these Amendments. All existing costs will be absorbed within each Department's budget.

FACTS AND PROVISIONS:

The agreement has been reviewed and approved as to form by County Counsel.

Unit, which Memorandum of Understanding was subsequently approved and ordered
implemented by the County's Board of Supervisors: and

WHEREAS, as a result of mutual agreement, the parties desire to amend the
MOU Article as set forth hereafter:

NOW, THEREFORE, the parties agree as follows:

1. Amend Article 4 – Term; to extend the Term of the MOU for 1 year to 12:00 midnight on January 31, 2013.

2. Amend Article 5 – Renegotiation; to reflect revisions in the renegotiation dates to correspond to a one year extension of the Term of the MOU:
 - Written notice to commence negotiations no later than September 7, 2012;

 - Salary proposal shall be presented no later than October 5, 2012;

 - Negotiations shall begin no later than October 15, 2012;

3. Amend Article 7 – Salaries, Section 6 (Sick Leave Accrual Exchange) to correspond to a one year extension of the Term of the MOU:
 - Change date for payment for up to 2 additional sick leave days on July 1, 2012;


4. Amend Article 40 Uniform, Section 4 to provide for payment for Uniform Allowance to correspond to extension of the Term of the MOU:
 - Change dates to November 1, 2012, December 1 & 15, 2012.


