PUBLIC HEARING
ANNEXATION OF PARCELS TO THE
MESA HEIGHTS GARBAGE DISPOSAL DISTRICT
(SUPERVISORIAL DISTRICT 2)
(3 VOTES)

SUBJECT

This action is to adopt a resolution of application for authorization to initiate proceedings with the Local Agency Formation Commission for Los Angeles County and file the required application to annex specific parcels into the Mesa Heights Garbage Disposal District.

IT IS RECOMMENDED THAT YOUR BOARD:

AFTER THE PUBLIC HEARING,

1. Find that this action is categorically exempt from the California Environmental Quality Act.
2. Adopt the enclosed resolution to request the initiation of proceedings before Local Agency Formation Commission for Los Angeles County for the annexation of subject parcels to the District.
3. Approve and authorize the Director of Public Works or her designee to file with Local Agency Formation Commission for Los Angeles County the required application to annex subject parcels to the District and take any other steps necessary to assist Local Agency Formation Commission for Los Angeles County in processing the application for annexation.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

It was recently determined that Consolidated Disposal Service, the County's contract waste hauler for the Mesa Heights Garbage Disposal District, has unknowingly been providing trash collection, recycling, and green waste collection services to parcels included in the proposed annexation at no cost to the property owners. These parcels currently fall under the open-market system wherein the residents would arrange for trash collection and recycling service directly with the waste hauler without any County involvement.

The purpose of the recommended actions is to annex unincorporated area parcels adjacent to the District in order to provide continued high-quality trash collection service and extend the benefits available to the District to the affected property owners. Upon approval of the annexation, an annual service fee will be collected through the property tax bill for trash collection, recycling, and green waste services to provide additional funding to assist the District in providing these services.

Implementation of Strategic Plan Goals

This action is consistent with the County Strategic Plan Goals of Operational Effectiveness (Goal 1), Community and Municipal Services (Goal 3), and Public Safety (Goal 5) since it will provide trash collection, recycling, and green waste collection services to the residents affected by the proposed annexation in a responsive, efficient, and cost-effective manner while protecting health and safety of residents, improving quality of life, and protecting the environment.

FISCAL IMPACT/FINANCING

There will be no impact to the County General Fund. Upon approval by your Board, this action will generate an estimated additional \$51,075 in yearly revenue in the Mesa Heights Garbage Disposal District effective July 1, 2013, which will be used to assist in financing operating expenses. The additional revenue will be included in the District's Fiscal Year 2013-14 Budget.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

The boundary of the proposed annexation has been reviewed and approved by Public Works and the County Assessor. The enclosed resolution requesting Local Agency Formation Commission for Los Angeles County to initiate proceedings for the annexation has been approved as to form by County Counsel.

ENVIRONMENTAL DOCUMENTATION

The proposed annexation is exempt from the California Environmental Quality Act pursuant to Title 14, Section 15319 of the California Code of Regulations since the parcels in this proposal contain existing private structures developed to the density allowed by the current zoning of either the gaining and losing jurisdiction and the extension of the services can only serve the existing facilities.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

The recommended action will have no impact on current County services or projects.

RESOLUTION OF APPLICATION

A RESOLUTION OF APPLICATION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF LOS ANGELES REQUESTING THE INITIATION OF PROCEEDINGS BEFORE THE LOCAL AGENCY FORMATION COMMISSION FOR LOS ANGELES COUNTY FOR THE ANNEXATION OF PARCELS TO THE MESA HEIGHTS GARBAGE DISPOSAL DISTRICT

WHEREAS, the County of Los Angeles ("County") finds that there is a need to extend the refuse, recycling, and green waste collection services that the District is currently receiving to adjacent unincorporated area parcels included in the proposed annexation; and

WHEREAS, the County desires to initiate proceedings pursuant to Part 3, Division 3, Title 5 of the California Government Code (commencing with Section 56000, the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000), for the annexation of parcels to the Mesa Heights Garbage Disposal District; and

WHEREAS, the proposed annexation is exempt from the California Environmental Quality Act pursuant to Title 14, Section 15319 of the California Code of Regulations; and

WHEREAS, the parcels that may be included in this proposal are as listed in Exhibit A attached hereto and by this reference incorporated herein; and

WHEREAS, the territories in the proposal are inhabited; and

WHEREAS, the proposed annexation would not affect any other local agency, as the services that will be provided by the District are not currently being provided by any other local agency in this territory; and

WHEREAS, the principal reason for the proposed annexation is to provide garbage disposal services including refuse, recycling, and green waste collection services to parcels, which currently is not within the boundaries of the District, and currently does not receive such services from any other local agency; and

WHEREAS, the proposed annexation is requested to be made subject to the following terms and conditions:

1. The subject parcels will be annexed to the Mesa Heights Garbage Disposal District pursuant to California Public Resources Code Section 49000 *et. seq.*, and the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000;

2. The Board of Supervisors is the governing body;
3. The Board of Supervisors, as governing body of the District, shall be authorized, in accordance with Public Resources Code Section 49030 *et. seq.*, to prescribe such assessments, service charges, fees or taxes upon the properties upon their annexation to the district as the District may legally impose; and
4. Any taxes, fees, charges or assessments for the District will be collected by the County of Los Angeles Tax Collector in the same manner as direct assessments or through another collection mechanism as the Board of Supervisors deems necessary; and

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Los Angeles, that:

1. The Board of Supervisors has found that the proposed annexation is categorically exempt from the California Environmental Quality Act;
2. The Board of Supervisors finds that there is a need to extend the refuse, recycling, and green waste collection services that the District is currently receiving to the adjacent unincorporated area parcels included in the proposed annexation;
3. This Resolution of Application to initiate proceedings is hereby adopted and approved, and the Local Agency Formation Commission for Los Angeles County is hereby requested to initiate proceedings for the annexation of the subject properties to the Mesa Heights Garbage Disposal District, pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 and in conformity of this resolution.

The foregoing resolution was on the ____ day of _____ 2012, adopted by the Board of Supervisors of the County of Los Angeles and ex officio the governing body of all other special assessment and taxing districts, agencies, and authorities for which said Board so acts.





NOTICE ON PROPOSED SERVICE FEE FOR GARBAGE COLLECTION,
RECYCLING, AND GREEN WASTE SERVICE IN THE EVENT THAT
SUBJECT PROPERTIES ARE ANNEXED TO THE
MESA HEIGHTS GARBAGE DISPOSAL DISTRICT**

As you may know, the County of Los Angeles Department of Public Works will be commencing the legal process to annex specific properties, including your property, into the Mesa Heights Garbage Disposal District (District). Attached is a map that illustrates the District's current boundary and the areas that will be affected by the proposed annexation. Currently, the District's residents enjoy benefits such as competitive trash collection and disposal service rates as well as reduced waste hauling traffic in their community. During this annexation time period, the County has acted on your behalf to provide you with these same benefits even though your property is currently located outside of the District. The annexation is being proposed to incorporate affected properties, including your property, into the District and ensure that these properties continue to receive high-quality trash collection service. However, if the annexation is not approved, your property will remain in the open-market system wherein residents directly arrange for services with the waste hauler which may result to unregulated rate increases and inconsistent quality of service. The estimated completion date of the annexation process is July 1, 2013.

If the annexation is approved, an annual service fee will be collected from your annual property tax bill for trash collection and disposal services. This service fee is calculated based on the number of "refuse units" assigned to each property use classification. For example, a parcel containing a single-family residential unit is assigned one refuse unit. The number of refuse units per parcel varies from one-half unit for a vacant parcel to 18 units for a community shopping center. Currently, the annual service fee is \$18.75 per refuse unit per month, which translates to \$225 per year. The service fee that will be collected from the subject properties is estimated to generate approximately \$51,075 of additional revenue for the District to assist in financing operating expenses for Fiscal Year 2013-14 through Fiscal Year 2014-15.

AVISO DE AUDIENCIA
SOBRE LA CUOTA PROPUESTA PARA EL SERVICIO DE RECOLECCIÓN DE BASURA,
RECICLAJE Y DESHECHOS VERDES EN CASO QUE CIERTAS PROPIEDADES SEAN
ADJUNTOS (ANEXIÓN) AL DISTRITO DE ELIMINACIÓN DE DESHECHOS DE MESA HEIGHTS

Como usted sabe, El Condado de Los Ángeles, Departamento de Obras Publicas iniciara el proceso legal para adjuntar o anexión de ciertas propiedades, incluyendo su propiedad al Distrito de Eliminación de Deshechos de Mesa Heights (Distrito). Se ha incluido un mapa que indica las zonas afectadas por la anexión propuesta. Actualmente, residentes del Distrito disfrutan de beneficios tales como la recolección de basura y tarifas competitivas, cuota de servicio bajas y reducción de trafico para el transporte de basura en su comunidad. Durante este periodo de anexión, el condado ha actuado en su nombre para seguir dándoles los mismos beneficios a pesar de que su propiedad se encuentra actualmente fuera del Distrito. La anexión se propone a incorporar las propiedades afectadas, incluyendo su propiedad, en el Distrito y asegurarse de que estas propiedades sigan recibiendo servicios de recolección de alta calidad. Sin embargo, si la anexión no es aprobada, su propiedad se mantendrá en el sistema de "mercado libre" donde los mismos residentes hacen arreglos para los servicios de recolección directamente con las empresas que pueden dar lugar a aumentos en las tarifas porque no son regulados y la calidad de servicios será desigual. La fecha prevista de finalización para el proceso de anexión es el 1^o de Julio 2013.

Si la anexión es aprobada, una cuota anual se recogerá de su factura de impuestos propietarios para el servicio de recolección de basura y eliminación de residuos. Este cargo de servicio se calcula en función del número de "unidades de deshechos", la clasificación asignada a cada uso de propiedad. Por ejemplo, una parcela que contenga una residencia unifamiliar se le asignara una (1) "unidad de desechos". El número de "unidades de deshechos" varía en cada parcela desde "media" unidad por un lote vacante a 18 unidades por un centro comercial dentro de una comunidad. Actualmente, la cuota para el servicio es de \$18.75 por cada "unidad de desecho" al mes, lo cual se traduce en \$225 por año. La cuota de servicio que se recogerá de las propiedades se estima a generar aproximadamente \$51,075.00 de ingresos adicionales para el Distrito. Esto ayudara a financiar los gastos de operación para el año fiscal 2013-14 hasta el año fiscal 2014-15.

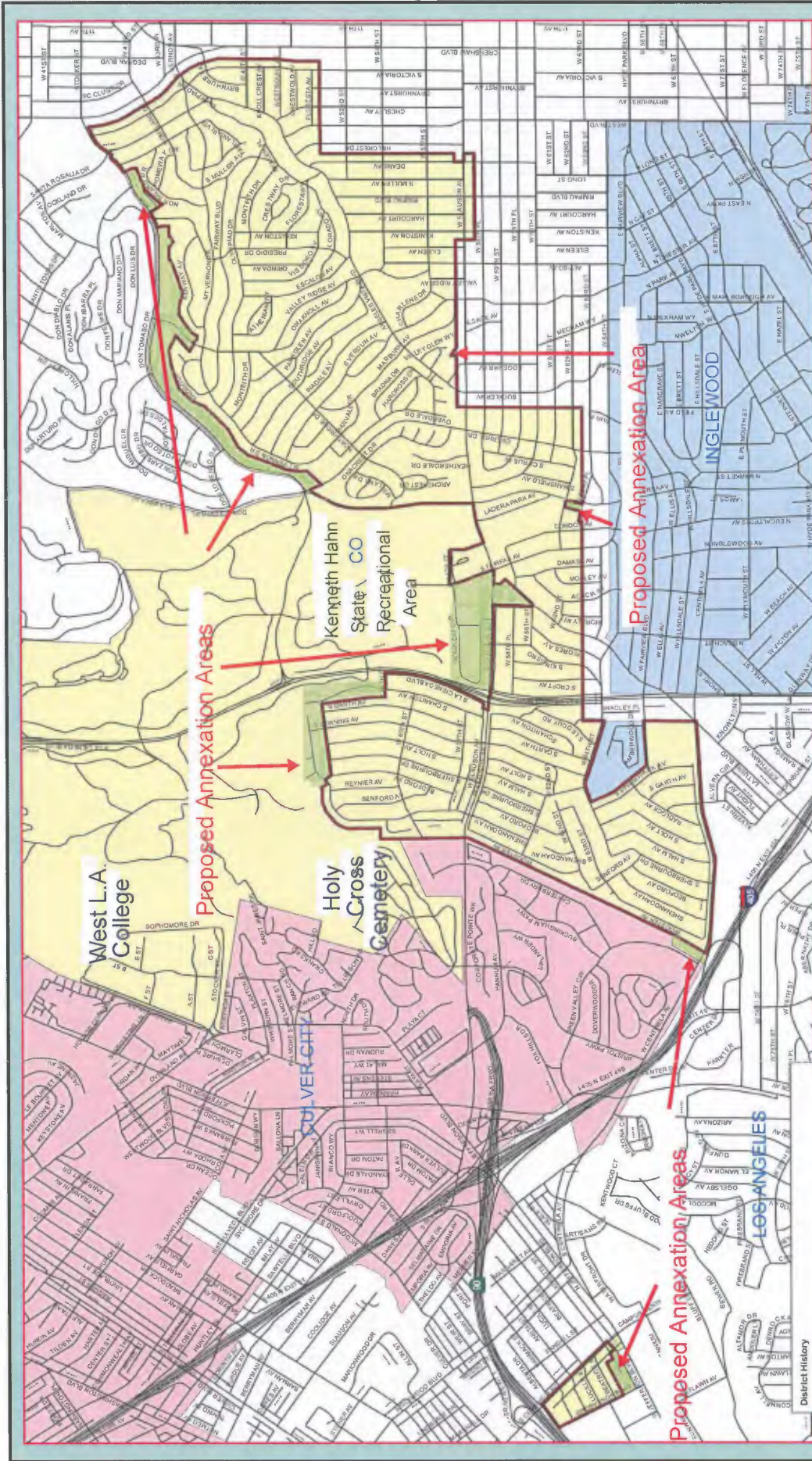
