#### RECOMMENDATION TO EXTEND 40 CALWORKS GAIN/GROW/GR DOMESTIC VIOLENCE SUPPORTIVE SERVICES CONTRACTS (ALL DISTRICTS - 3 VOTES)

## SUBJECT

The Department of Public Social Services (DPSS) seeks Board approval to extend 40 California Work Opportunity and Responsibility to Kids/Greater Avenues for Independence/General Relief Opportunities for Work/General Relief Domestic Violence (CalWORKs GAIN/GROW/GR DV) Supportive Services contracts listed in Attachment A, for a period of six months, effective July 1, 2012 through December 31, 2012. The existing 40 contracts are set to expire on June 30, 2012.

# IT IS RECOMMENDED THAT YOUR BOARD:

Delegate authority to the Acting Director of DPSS or her designee, to execute amendments to the 40 CalWORKs GAIN/GROW/GR DV Supportive Services Program contracts listed in Attachment A, through an amendment substantially similar to Attachment B. The amendments will extend the contract term for a period of six months effective July 1, 2012 through December 31, 2012, for the provision of domestic violence services in the five Los Angeles County Supervisorial Districts. Attachment A provides the estimated funding allocations for a six-month period for each of the 40 CalWORKs GAIN/GROW/GR DV Supportive Services contracts. The overall six-month total contract cost for these DV services is \$6,297,566 funded by CalWORKs Single Allocation, CalFresh Employment and Training, and net County cost (NCC) funds.

## PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Approval of the recommended action will 1) enable DPSS to continue with the administration of contracts for the provision of case management and legal services to CalWORKs participants and

their minor children and GR/GROW participants who are victims of domestic violence, 2) enable DPSS to establish standards for costs associated with domestic violence-related services, and 3) minimize County costs associated with the solicitation process by combining procurement of both the CalWORKs GAIN/GROW/GR Domestic Violence Supportive Services Program with the Domestic Violence Shelter Based Program contracts which are set to expire on December 31, 2012, into one effort.

Continuing the operation of the CalWORKs GAIN/GROW/GR DV Supportive Services Program will provide sufficient time to complete and execute the new contracts without disruption of domestic violence services. The six-month contract extension will assist the Department in ensuring that a competitive solicitation is successfully executed and new contracts are in place effective January 1, 2013.

#### **Implementation of Strategic Plan Goals**

This recommendation is consistent with the principles of the Countywide Strategic Plan, Goal 1: Operational Effectiveness: Maximize the effectiveness of processes, structure and operations to support timely delivery of customer-oriented and efficient public services.

### **FISCAL IMPACT/FINANCING**

Funding for these services for Fiscal Year (FY) 2012-13, is included in the Department's FY 2012-13 Budget. The overall total estimated cost for the 40 contracts for the six-month period of July 1, 2012 through December 31, 2012 is \$6,297,566, of which \$6,177,116 will be funded through Single Allocation for the CalWORKs/GAIN services with no NCC impact. The estimated GROW portion will be \$90,337, of which \$45,169 is funded with CalFresh Employment and Training funds and \$45,168 is NCC. The estimated GR portion will be \$30,113 which is 100 percent NCC. The total NCC impact is \$75, 281.

### FACTS AND PROVISIONS/LEGAL REQUIREMENTS

The CalWORKs/GAIN/GROW/GR DV Supportive Services Program provides case management and legal services to CalWORKs and GROW/GR participants and their minor children. The program allows for the provision of services that include, but are not limited to, crisis intervention, counseling, transportation, shelter, food, and clothing that will assist in their safety and survival to move them toward self-sufficiency.

Through this recommended action, the Acting Director of DPSS may execute amendments to the CalWORKs/GAIN/GROW/GR DV Supportive Services contracts to extend the current term for an additional six months so that services will continue without interruption. A copy of all amendments will be provided to the Executive Office of the Board of Supervisors and the CEO within ten days of execution.

The Amendment to extend the contracts is in compliance with all Board and CEO requirements and has been approved as to form by County Counsel.

### **CONTRACTING PROCESS**

The current contracts were awarded in 2008 as a result of a solicitation performed by the Department of Community and Senior Services. Administrative responsibility for the contracts was

transferred to DPSS in 2009. California Department of Social Services approved the extension of these contracts for an additional six months.

### **IMPACT ON CURRENT SERVICES (OR PROJECTS)**

Approval of the recommended actions will enable DPSS to continue providing CalWORKs GAIN/GROW/GR DV Supportive Services to participants and their minor children. The continuation of these services will enable them to overcome barriers to employment and assist them to move toward self-sufficiency.

WHEREAS, reference is made to the document entitled "CALWORKS GAIN/GROW/GR DOMESTIC VIOLENCE SUPPORTIVE SERVICES PROGRAM" entered into between the County of Los Angeles, ("COUNTY"), and **«Agency Name»** ("CONTRACTOR") commenced on July 1, 2008, and further identified as Contract No. **«Contract Number»**, and any amendments thereto, hereinafter collectively referred to as "Contract."

WHEREAS, COUNTY has created a CalWORKs Domestic Violence Supportive Services Program, pursuant to Section 11322.6 of the California Welfare and Institutions Code, herein after referred to as "Program."

WHEREAS, COUNTY has authority to provide domestic violence services pursuant to Assembly Bill (AB) 1542, Chapter 270, Statues of 1977 All County Information Notice 1-51-97.

**WHEREAS**, the parties hereto have previously entered into the above referenced Contract for the purpose of providing case management, counseling, emergency and transitional shelter, legal and other services to CalWORKs participants, assisting them in overcoming barriers to employment and moving toward self-sufficiency, and

WHEREAS, on June 24, 2008 the Los Angeles County Board of Supervisors delegated authority to the Director of Community and Senior Services (CSS) to 1) execute contracts and allocate funds for the contract period beginning July 1, 2008 through June 30, 2011; and 2) execute contract amendments within the contract term to increase or decrease contract amounts.

WHEREAS, on May 5, 2009 the Board of Supervisors was notified of the CEO's recommendation, as part of the FY 2009-10 Proposed Budget, to transfer all DV programs from CSS to DPSS.

WHEREAS, on June 29, 2009 the above referenced contract was amended to delegate authority to the Director of the Department of Public Social Services to 1) execute contracts and allocate funds for the contract period beginning July 1, 2009 through June 30, 2011; and 2) execute contract amendments within the contract term to increase or decrease contract amounts.

**WHEREAS**, COUNTY has determined that CONTRACTOR'S performance has been satisfactory, that the need for services continues to exist, and that funding for such services is currently available; and

**WHEREAS**, COUNTY and CONTRACTOR desire to amend this Contract in accordance with the terms and conditions as set forth below:

NOW, THEREFORE, THE PARTIES HERETO AGREE AS FOLLOWS:

- 1. This Amendment shall commence and be effective upon execution.
- 2. Contract, Part 1, UNIQUE TERMS AND CONDITIONS, Section 3.0, Term and Termination, Subsection 3.1 is deleted in its entirety and replaced as follows:
  - 3.1 The term of this Contract shall be from July 1, 2008 through December 31, 2012, unless terminated earlier, by whole or in part, as provided in this Contract.
- 3. Contract, Part 1, UNIQUE TERMS AND CONDITIONS, Section 4.0, Contract Sum, is amended to add Subsection 4.3.2 as follows:
  - 4.3.2 The Maximum Contract Sum for the period from July 1, 2012 through December 31, 2012 is \$\_\_\_\_\_ as outlined in Exhibit B-4, Exhibit B-5, Statement of Work and in Exhibit C-3, Budget.
- 4. Exhibit B, STATEMENT OF WORK is modified to add Exhibits B-4 and B-5, Statement of Work, attached hereto and incorporated herein by reference.
- 5. Exhibit C, BUDGET, is modified to add Exhibit C-3, Budget, attached hereto and incorporated herein by reference.
- 6. Except for the changes set forth hereinabove, Contract shall not be changed in any respect by this Contract.
