Vice Chair Huizar introduced new Director, Steve Valenzuela representing the Community Redevelopment Agency of the City of Los Angeles (CRA/LA) a Designated Local Authority.

4. Update on the Letter of Understanding Re: Term Sheet and Consideration of Phase IA Design Architect Proposed by Developer - Dawn McDivitt. (13-3418)

Dawn McDivitt, Chief Executive Office, reported that Robert A.M. Stern Architects (RAMSA) was selected as the design architect firm for the Grand Avenue Project - Phase 1A.

Bill Witte, Related Company, expressed his satisfaction on the selection of RAMSA as the design architect. Mr. Witte stated that RAMSA has an extensive amount of experience and is confident that they will meet expectations.

In response to questions posed by Director Valenzuela, Mr. Witte indicated that there is no master plan; however, they have been working with Gensler in phases to look for a template that will work for the entire site. Mr. Witte also indicated that each step of the project is submitted before the Board for approval and based on projects they have completed there are no concerns that the Architect will lessen the quality as time passes.
