ACCEPTANCE OF AN EQUIPMENT DONATION FROM IGT LLC DBA EIGEN FOR LAC+USC MEDICAL CENTER, UROLOGY DEPARTMENT (SUPERVISORIAL DISTRICT 1) (3 VOTES)

SUBJECT

Request approval to accept an equipment donation of an Artemis Prostate Biopsy System, the supporting Profuse Software and related one-year service maintenance warranty at a combined value of \$270,000 from IGT LLC dba Eigen to LAC+USC Medical Center, Urology Department.

IT IS RECOMMENDED THAT THE BOARD:

- Accept an equipment donation of an Artemis Prostate Biopsy System. (Artemis), supporting Profuse Software, and one-year service maintenance warranty valued at a combined total of \$270,000.
- Instruct the Executive Officer, Board of Supervisors, to prepare and send a letter of appreciation to Eigen for the generous donation of the Artemis (Attachment I).

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

In accordance with County policy, donations in excess of \$10,000 require acceptance by the Board of Supervisors.

Approval of the first recommendation will allow the facility to accept the gift donation and will enhance the quality of services delivered to Urology patients at LAC+USC Medical Center (LAC +USC MC).

Eigen is the leader in manufacturing 3D semi-robotic targeted prostate biopsy with MRI/TRUS fusion. Artemis received FDA approval in May 2008. The Artemis allows for more accurate diagnosis of prostate cancer during biopsy. Many biopsies can miss early stages of cancer. Artemis allows the Urologist see inside the prostate in virtual 3D while providing real time navigation and biopsy needle mapping. It also generates a 3D image of the biopsy coordinates for future evidence. Additionally Artemis technology allows for sophisticated recording of actual biopsy sites samples. The system greatly increases the ability to examine the prostate for abnormalities or suspicious areas which may need sampling.

Approval of the second recommendation will acknowledge the receipt of this generous donation by Eigen.

Implementation of Strategic Plan Goals

The recommended actions support Goal 1, Operational Effectiveness, of the County's strategic plan.

FISCAL IMPACT/FINANCING

There is a one-time cost associated with acceptance and installation of the Artemis and software. LAC+USC MC has been asked to pay for shipping at a cost of no more than \$1,000 and installation at a cost of \$2,500 for a total of \$3,500. Funding is included in the Department of Health Services' Fiscal Year 2013-14 Adopted Budget.

The cost of the device, the one-year warranty with maintenance will be covered by the donor, free of charge.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

Section 2.4.2 of the County Fiscal Manual authorizes County departments to accept donations in excess of \$10,000.00 with Board approval.

There is no financial interest or any other relationship between LAC+USC MC and Eigen.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

Approval of the recommended actions will help improve the quality of health care services delivered to urology patients at LAC+USC MC.

This letter is to confirm that IGT, LLC, dba Eigen is donating our cutting-edge technology for targeted prostate biopsy to the Los Angeles County, USC Medical Center, Urology Division, Dr. Ukimura. Our system is comprised of:

Artemis[™] — the image guidance and 3D navigation tool for prostate biopsy ProFuse[™] — the MRI targeted planning software ProFuse Bx[™] — the fusion platform

Located in Grass Valley, California, Eigen is the proud manufacturer of such advanced technology. Our company is committed to making a difference in the early detection of prostate cancer by providing such an advanced and well-validated tool for use by radiologists and urologists. It is a pleasure to make this technology available to the male population served at the LA county hospital.

This advanced technology enables physicians to unblind the so-called "blind" prostate biopsy method. Such a blind biopsy method recently failed to detect Governor Jerry Brown's prostate cancer at an early stage. LICENSE GRANTS

Software. Subject to all terms and conditions in this Agreement, Eigen grants Licensee a nonexclusive, nontransferable, nonsublicenseable right and license to have the User use the Products and Documentation without modification.

License Control. Licensee acknowledges that the Software may contain code or require devices that detect or prevent unauthorized use of, or disable, the Software.

OWNERSHIP

The foregoing license gives you limited license to use the Products. Eigen and its suppliers retain all right, title and interest, including all copyright and intellectual property rights, in and to, the Software (as an independent work and as an underlying work serving as a basis for any application you may develop), and all copies thereof. All rights not specifically granted in this EULA, including Federal and International Copyrights, are reserved by Eigen and its suppliers.

PROPRIETARY RIGHTS

Restrictions. Licensee shall not (a) use any Confidential Information to create any software, Documentation or Products similar to those licensed, (b) disassemble, decompile, reverse engineer or otherwise try to discover any source code or underlying structures, ideas or algorithms of the Products (except and only to the extent these restrictions are expressly prohibited by applicable statutory law), (c) encumber, lease, rent, loan, sublicense, transfer or distribute any Software, (d) copy, adapt, merge, create derivative works of, translate, localize, port or otherwise modify any Software or Documentation, (e) use the Software in an automated process, (f) use the Software, or allow the transfer, transmission, export or re-export of all or any part of the Software or any product thereof, in violation of any export control laws or regulations of the United States or any other relevant jurisdiction or (g) permit any third party to engage in any of the foregoing proscribed acts. The failure of either party to enforce its rights under this Agreement at any time for any period will not be construed as a waiver of such rights. If any provision of this Agreement is determined to be illegal or unenforceable, that provision will be limited or eliminated to the minimum extent necessary so that this Agreement will otherwise remain in full force and effect and enforceable.
