

Non-Compliant in SAPC

The total number of non-compliant PSPs referred to DPH-SAPC via the Community Assessment Services Center (CASC) for substance abuse treatment is 1,389. This number represents the unique number of PSPs who arrived at CASC, were assessed and met the criteria for treatment since the inception of the AB 109 program. The table below demonstrates the number of PSPs that have reoffended out of the 1,389 non-compliant PSPs referred to DPH-SAPC for substance abuse treatment.

AB 109 Substance Use Disorder Discharge Definition

Completion:

- Client completed goals and objectives identified in the treatment plan.
- Development of a discharge plan/continuing care plan which includes recovery support (work, education, housing, health, support groups) and exit interview with primary counselor.



AB 109 Substance Use Disorder Discharge Definition Continued...

Non-Completion with Satisfactory Treatment Progress:

Client did not complete treatment and made significant progress towards treatment plan goals and objectives.

Non-Completion with Unsatisfactory Treatment Progress:

Client dropped out of or has been discharged for non-compliance (positive drug tests, no-show for groups).
