UNINCORPORATED AREA PATROL SERVICE LEVELS (ITEM NO. 50, AGENDA OF APRIL 15, 2014)

On April 15, 2014, Supervisor Antonovich directed the Chief Executive Office (CEO) to work with the Sheriff's Department (Department) to report back on the service levels of unincorporated area patrol as part of the Fiscal Year (FY) 2014-15 Budget Deliberations.

Attached is the Department's 2014 assessment of law enforcement services in the unincorporated areas which includes a historical view of service levels – specifically comparing the level of law enforcement services between 2010 and 2013; statistical data; a review of past deployment practices; and an assessment of current and future needs in the unincorporated areas of Los Angeles County.

In 2006, after a review of law enforcement services in the unincorporated areas, the Department requested 212 deputy sheriff positions for unincorporated area patrol. The CEO recommended, and the Board approved, a total of 131 deputy sheriff positions and 14 professional staff. In FY 2010-11, the Department's budget was curtailed by over \$100 million, which included the elimination of 300 budgeted/vacant deputy sheriff positions. As a result, 65 deputies were curtailed from unincorporated area patrol and have not been restored.

Based on the 2014 assessment, the Department indicates that 123 additional deputy sheriff positions are needed at a total estimated cost of \$22.9 million. Please note that this study focused solely on the delivery of patrol services and therefore did not address the need for support personnel or professional staff that may support patrol operations.

Given the significant costs associated with this request, the CEO recommends that the Department develop a phased approach for implementation over a two-year period. After a review and analysis of the Department's multi-year implementation plan, the CEO will then submit a recommendation to the Board for consideration during FY 2014-15 supplemental changes.

EXECUTIVE SUMMARY

This study is a review of the level of law enforcement service in the unincorporated areas of Los Angeles County. This report provides a historical look at the service levels provided in the unincorporated areas of the county, and specifically compares the level of law enforcement services between 2010 and 2013. Statistical information for this report was provided by the Crime Analyst Program (CAP) and reviewed by the staff at Contract Law Enforcement Bureau. This report considered past deployment practices in the unincorporated areas and provides an assessment of current and future needs in the unincorporated areas of Los Angeles County.

Background

After a 2006 review of law enforcement services in the unincorporated county areas, the Sheriff's department recommended that 212 sworn deputies be added to these areas. Approval for 105 sworn and 8 professional staff positions was granted and these items were funded in FY 2007/2008. The following year, FY 2008/2009, an additional 26 sworn and 6 professional staff members were funded. These sworn service levels remained until FY 2010/2011, when 65 sworn positions were curtailed. As of 2013, these curtailments have not been restored.

Study Parameters

This report provides information relating to the four Patrol Divisions for the Sheriff's Department. These Divisions, when combined, are responsible for patrol operations for all of the county's unincorporated communities. This study examines several parameters and indicators. The areas studied include:

- Response times to calls for service,
- Deputies assigned,
- Deputies per 1,000 population,
- Deputies per Part I crime (serious felonies),
- Deputies per Part II crime (non-serious felonies, misdemeanors),
- Reports taken per deputy (URNS),
- Calls for service, per deputy, and
- Arrests per deputy.

These parameters were identified and used in previous “Unincorporated Area Patrol Assessment” reports. The charts in the following sections illustrate the relative data between the service provided in 2010 and 2013.

This review is displayed in both numerical and graph format and shows a side by side comparison between the service levels provided in both 2010 and 2013, in the unincorporated areas within the respective Sheriff station’s jurisdiction.

This study was an unincorporated patrol assessment that did not include support personnel or professional staff. Supplemental services that support patrol operations were considered; however, the main focus was on the delivery of law enforcement services by patrol deputies. The introduction of more deputies into unincorporated patrol may require additional support personnel and professional staff.

Study Findings

Every station in each Sheriff’s patrol division was reviewed in this study. In addition to conducting data analysis, each station commander conducted an independent patrol assessment of their station to provide input concerning variables that are specific to their station. The station commanders were encouraged to meet and discuss their assessment with their respective supervisorial field deputies. Recommendations from station commanders were identified and considered in this study.

Using the identified parameters, there were some Sheriff’s stations that did not reflect a significant need for an increase in deputies. However, some stations clearly demonstrated a need for additional deputies. The stations that were identified as requiring an increase in deputies are listed under their respective divisions, along with a brief justification.

Conclusion

This study specifically compared the service levels of unincorporated patrol between 2010 and 2013. 2010 was the last year before the countywide unincorporated areas suffered a 65 deputy curtailment and personnel was reduced. This Patrol Assessment reviewed specific empirical data and considered the assessment of station commanders. It was determined the unincorporated areas are in need of additional deputy personnel.

This study recommends the addition of 118 budgeted Deputy Sheriff Generalist and five Deputy Sheriff Bonus-I positions to specifically patrol the unincorporated county areas. Associated with this personnel recommendation will be a slight increase in support personnel, supervision and vehicles.

The estimated budgeted cost for the expansion of unincorporated area patrol services is approximately \$19,489,401.20. This cost is based upon FY 13/14 rates.

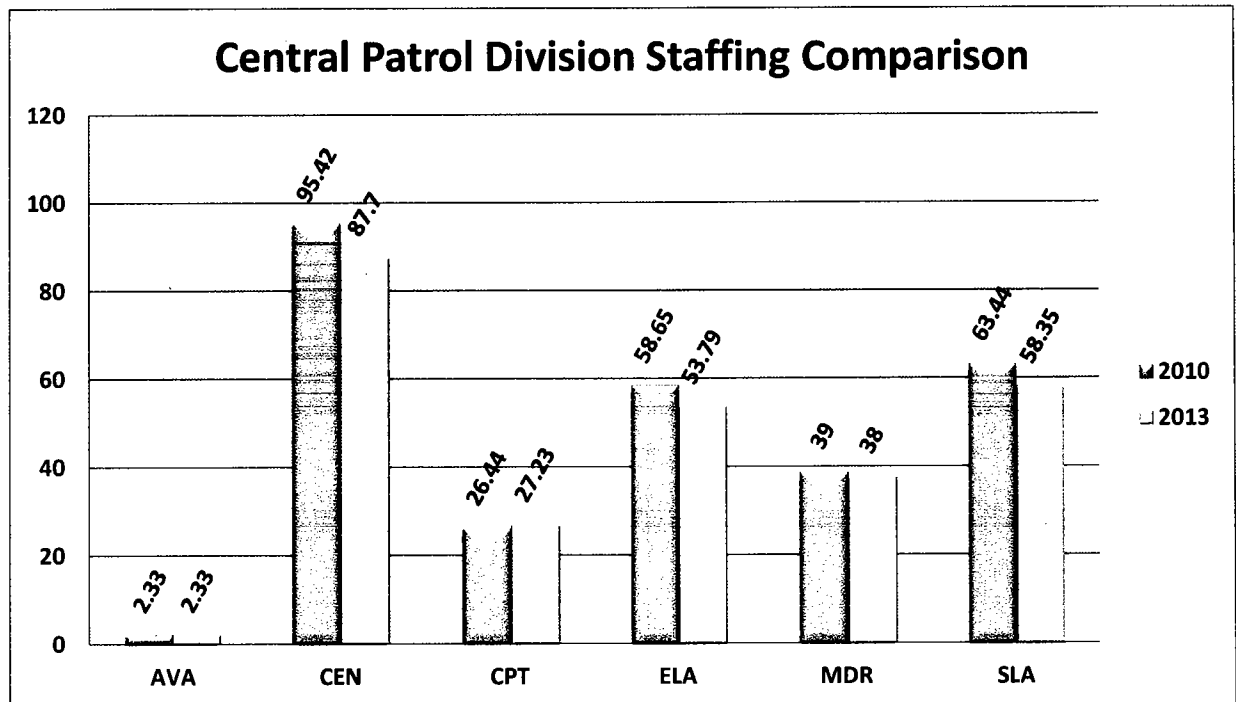

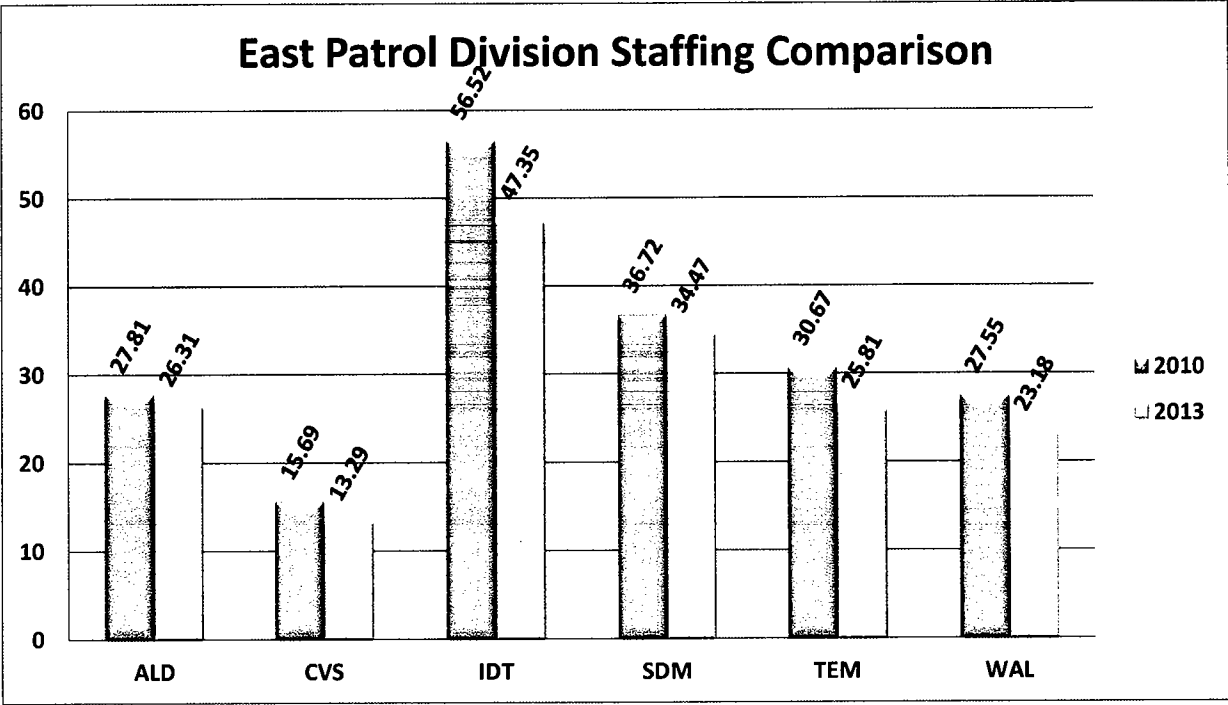

North Patrol Division

- Lancaster Station

Lancaster station covers a large unincorporated area and on average it takes deputies approximately 92 minutes to respond to a routine call for service. In 2013 it took deputies longer to respond to Emergency and Priority calls than it did in 2010. Since 2010, there has been a slight increase in the number of calls for service and the number of reported incidents. Additional deputies could be used in the outlying areas to reduce response times, increase directed patrols and to improve officer safety.

- Malibu / Lost Hills Station

Malibu / Lost Hills station covers a large unincorporated area. Since 2010, there was a significant increase in Part I crimes and reported incidents. There was also an increase in Part II crimes and calls for service. It is also took deputies longer to respond to Emergency and Routine calls for service than it did in 2010. Deputies generally responded from call to call and conducted limited routine patrol. Community concerns regarding lack of visibility were raised by business owners and residents in the unincorporated areas.

- Palmdale Station

Palmdale station covers a large geographical patrol area. While overall crime has slightly decreased, it took deputies approximately 94 minutes to respond to a routine call for service. Additional deputies could be used in the outlying areas to reduce response times, increase directed patrols, and improve officer safety.

- Santa Clarita Valley Station

Given recent annexations, Santa Clarita Valley station has seen a decrease in the unincorporated area population. Even with this decrease, the station has seen an increase in the number of reported incidents. It is also took deputies longer to respond to Priority calls for service than it did in 2010. On average, it took deputies about 63 minutes to respond to a routine call for service in the unincorporated areas. Developers are currently building new communities in the unincorporated areas.

- West Hollywood Station

West Hollywood station is unique in that it serves the Universal Studios and the Universal City Walk area. Deputies work in conjunction with security guards to provide public safety services. The workload at Universal City Walk is seasonal and peaks on the weekends. The amusement park has significantly expanded since 2010 and daily populations have increased. There is a large demand for investigations due to employee theft and fraud associated with the park. The station has seen an increase in the number of Part I and Part II crimes and an increase of reported incidents. It is also taking deputies longer to respond to Emergency and Priority calls for service than it did in 2010.

Central Patrol Division

- Avalon Station

Avalon station has unique challenges that warrant additional services - The Isthmus deputies have no relief, seasonal increase in workload and the location of Isthmus hinders timely back-up. The station is responsible for providing maritime patrols and water rescues for both Catalina and San Clemente islands. These patrols require a two deputy operation. The maritime patrols also focus on the increased activities of drug smuggling and human trafficking via the Catalina waterways.

- Century Station

Century station has seen an increase in the number of Part I crimes, which includes homicides and assaults in the unincorporated area of Florence-Firestone. It also has seen an increase in population and number of calls for service. This station's unincorporated areas are spread-out and it takes deputies approximately 52 minutes to respond to a routine call for service.

- Compton Station

Compton station has seen an increase in the calls for service. In 2013 it took deputies longer to respond to Emergency calls for service than it did in 2010. The station would also like to improve community outreach and youth programs in the unincorporated areas that mirror the success they have had with contract city programs.

- East Los Angeles Station

East Los Angeles station has experienced an increase in arrests, Part II crimes and calls for service. It has also seen a slight increase in population. Response times for routine calls have increased since 2010, with an average response time of approximately 68 minutes for Routine calls. The station is requesting the Crime Enforcement Team that is currently funded by Supervisor District 1 discretionary funds be part of the station's annual budget.

- Marina Del Rey Station

Marina Del Rey station has experienced increases in the number of arrests, number of reported incidents, calls for service and number of Part I and Part II crimes. It is also taking deputies longer to respond to Emergency, Priority and Routine calls for service. Currently, housing developments are being built in the unincorporated areas that will significantly increase the population.

- South Los Angeles Station

South Los Angeles station has experienced an increase in the number of reported incidents and a slight increase in number of calls for service and population. This station would like to start a special assignment team in the unincorporated area for directed patrol missions.

South Patrol Division

- Carson Station

Carson station has experienced a significant increase in workload, specifically in the calls for service, Part I crimes, reported incidents and arrests. There has also been an increase in the amount of time it takes deputies to respond to Emergency and Routine calls for service.

- Cerritos Station

There are no unincorporated areas in this station's jurisdiction.

Lomita station has experienced an increase in Part II crimes, calls for service, reported incidents and arrests. The unincorporated areas in this station's jurisdiction are spread-out which impacts response times. The average response time for a routine calls for service was approximately 30 minutes.

- Norwalk Station

Norwalk station has seen an increase in both Part I and Part II crimes since 2010, it has also had an increase in reported incidents, calls for service and population. The response times for Emergency and Routine calls for service have increased since 2010. The average time to respond to a Routine call was approximately 38 minutes. The station would like to see an increase in personnel to improve response times and officer safety.

- Pico Rivera Station

This station has experienced an increase in Part I crimes, reported incidents and calls for service. There has been an increase in response times for Emergency, Priority and Routine calls for service. The unincorporated areas are separate and not connected. Challenging geography, consisting of freeways and large riverbeds, hinder rapid responses to calls.

East Patrol Division

- Altadena

Altadena station had an increase in the number of calls, arrests and reported incidents. There has also been an increase in Part I and Part II crimes. When deputies are needed in the mountainous areas, field units that normally patrol the metropolitan areas, must leave these areas to respond to the mountains. In Addition, this station now provides service to schools in the unincorporated Pasadena areas, since the Pasadena school police department was absorbed by the Pasadena Police department.

- Crescenta Valley Station

Crescenta Valley station has seen an increase in calls for service and arrests. There was an increase in response times for Emergency and Routine calls for service, with the average Emergency response time of 10 minutes. The geographical area of this station's jurisdiction is unique as it has a large patrol area. Given the remote and rugged terrain, there can be intermittent radio service, limited air support, and extended response times for deputies working in the early morning hours. When deputies are needed in the mountainous areas, field units that normally patrol the metropolitan areas, must leave these areas to respond to the mountains.

- Industry Station

Industry station has two very large, densely populated unincorporated areas. Since 2010, there has been an increase in Part I crimes and calls for service. There has been an increase in the amount of time it takes deputies to respond to Routine and Priority calls.

- San Dimas Station

San Dimas station has a large patrol area. It has experienced an increase in the number of calls for service, Part I crimes and population. Since 2010, there has been an increase in the amount of time it takes deputies to respond to Emergency calls. When deputies are needed in the mountainous areas, field units that normally patrol the metropolitan areas, must leave these areas to respond to the mountains.

- Temple Station

Temple station has had an increase in Part I crimes and calls for service. There has been an increase in the amount of time it takes deputies to respond to Priority calls and the average time to respond to Routine calls is approximately 48 minutes. Unincorporated areas are spread-out in multiple unincorporated islands and deputies spend a disproportionately high amount of time responding to calls rather than patrolling in specific unincorporated areas. The Rosemary Children's Services housing facility, in the unincorporated Pasadena area, requires a huge demand for law enforcement resources.

- Walnut Station

Walnut station had an increase in Part I and Part II crimes. There was also an increase in calls for service, reported incidents and arrests. Since 2010, there has been an increase in the amount of time it takes deputies to respond to an Emergency call for service.

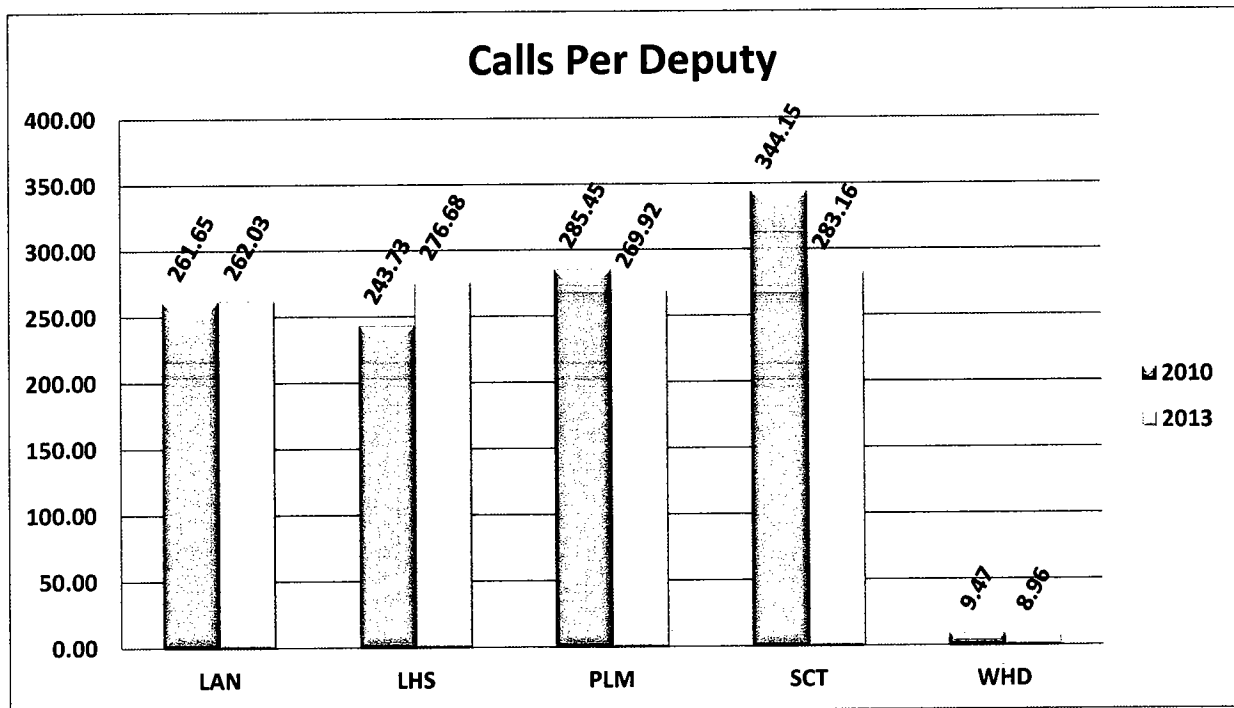
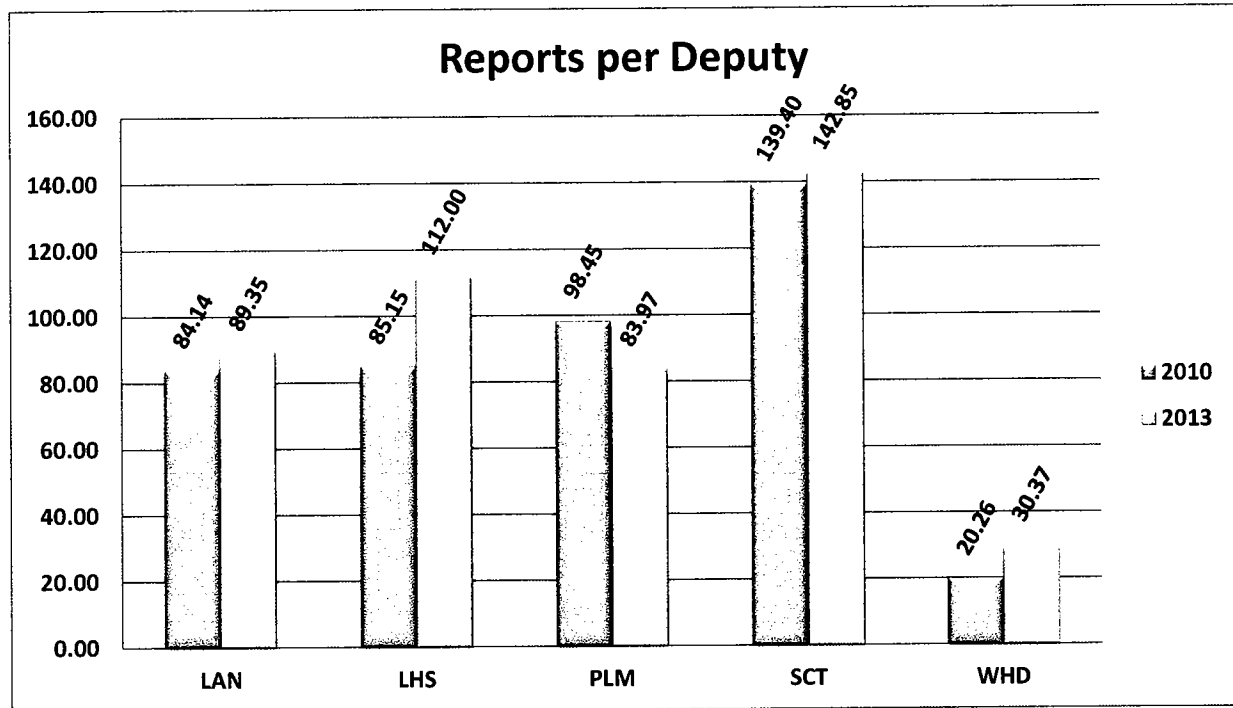
North Patrol Division 2010/2013 Comparison



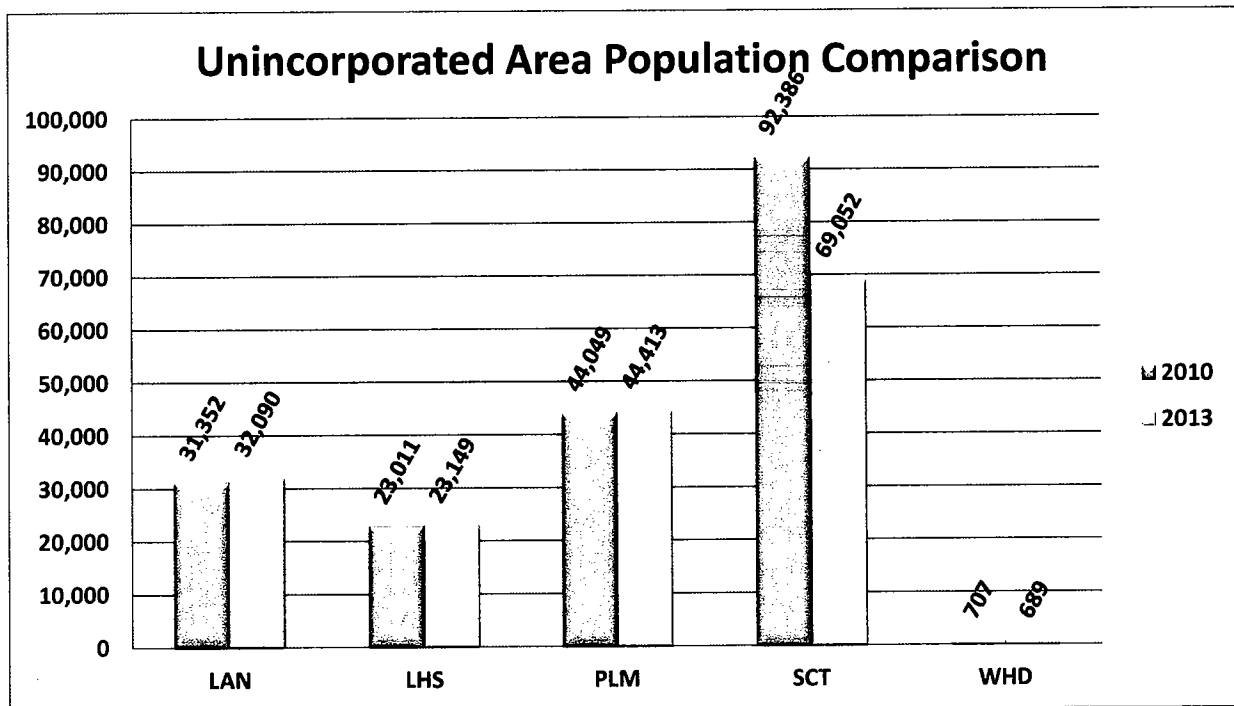
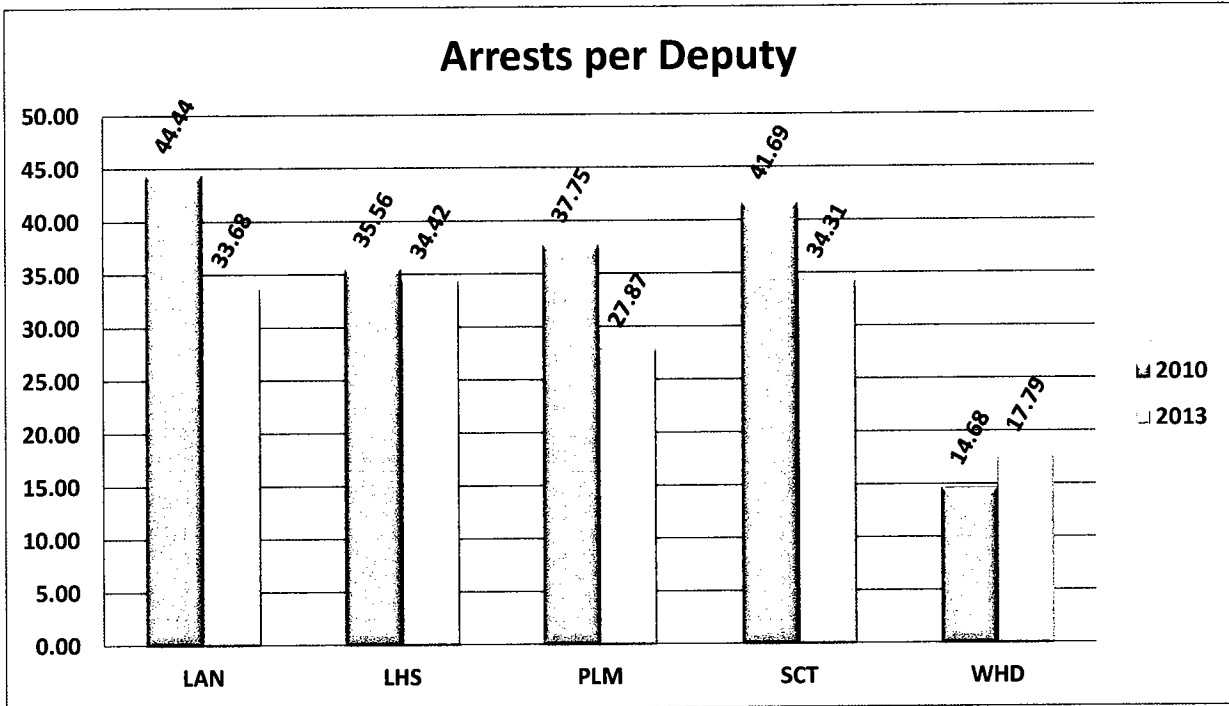
North Patrol Division 2010/2013 Comparison



North Patrol Division 2010/2013 Comparison

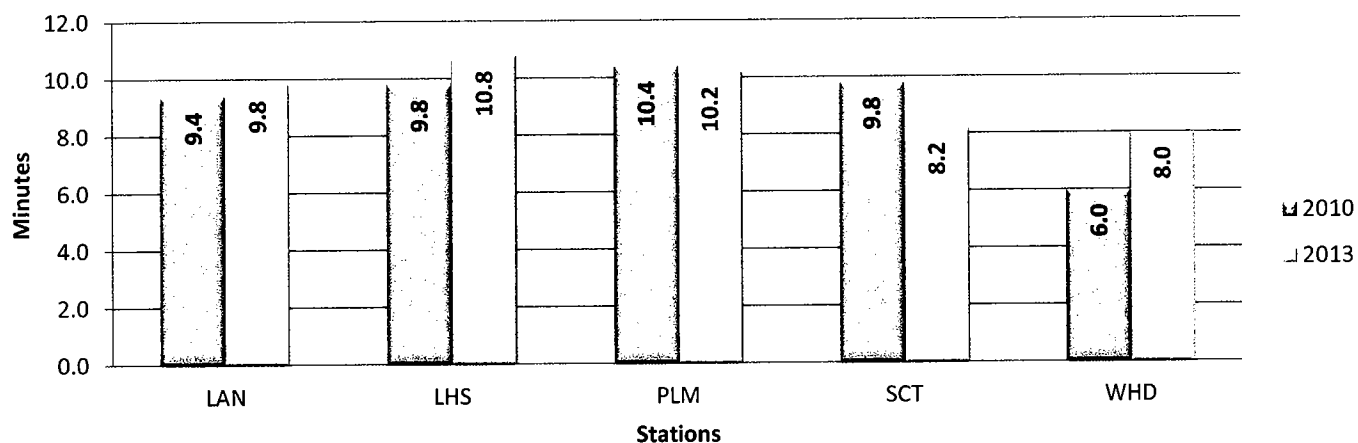


North Patrol Division 2010/2013 Comparison

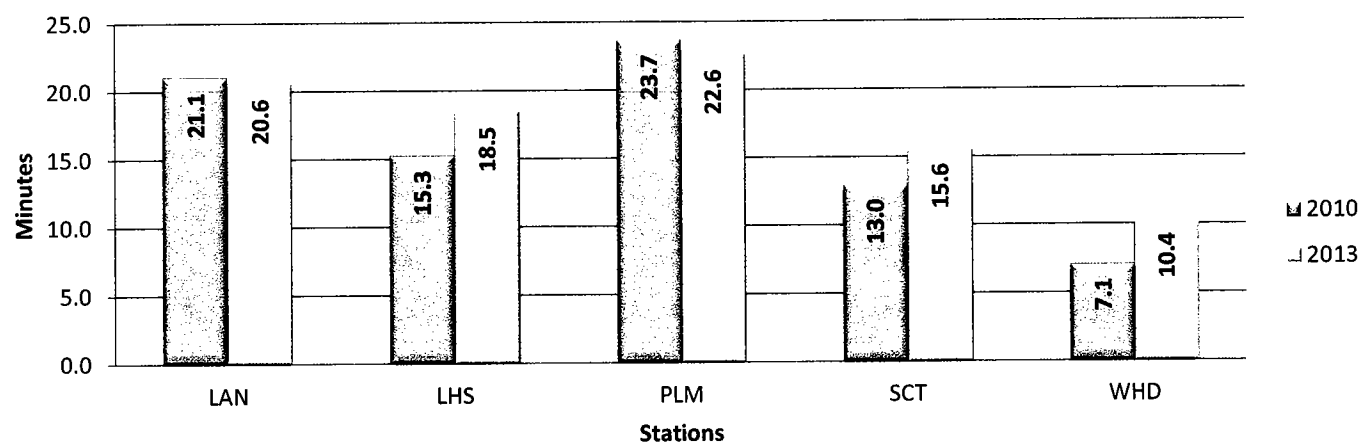


2014 North Patrol Division Response Time Comparison

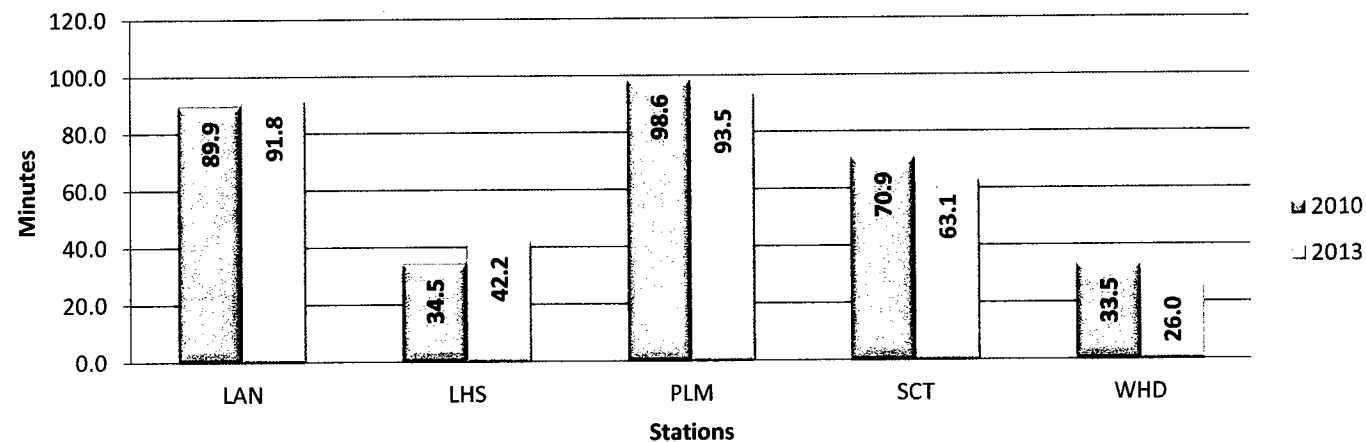
2010/2013 Emergent Response Time Average
