SUBJECT: **MOTION RESPONSE REPORT ON VIRGINIA ROBINSON GARDENS  
EXPANDED OPERATING HOURS PILOT PROGRAM (AGENDA  
ITEM 14, BOARD OF SUPERVISORS MEETING OF AUGUST 12, 2014)**

On August 12, 2014, your Board approved the Final Supplemental Environmental Impact Report (FSEIR) for Virginia Robinson Gardens (Gardens), which proposed operational changes to allow more access for visitors, including opening the Gardens on Saturdays and holidays and extending the hours of operation by 30 minutes daily. At the same time, Supervisor Zev Yaroslavsky brought in a motion instructing the Department of Parks and Recreation (Department) to:

- 1) Institute a 12-month pilot program in which the Garden limits its Saturday hours to two Saturdays per month;
- 2) Return to the Board 30 days after the completion of the pilot program with an evaluation of the Saturday use based on attendance, number of complaints, and impacts, if any, to neighbors; and
- 3) Make a recommendation to the Board as to continuing Saturday hours of operation.

The motion also recognized the efforts of the Department and Friends of Robinson Gardens who have worked tirelessly to make this multi-faceted property more accessible to the public without impacting the neighborhood.

As directed, the Department implemented Saturday operations twice a month for the pilot program starting August 12, 2014, for garden events that relate to the historical context of the Gardens. Attendance, requests for usage, parking locations and impacts, concerns and/or complaints from neighbors were closely monitored and tracked.

The pilot program was completed on August 12, 2015. Tours during the pilot program were conducted without incident and without any complaints. Due to limited Saturday availability, the Gardens denied several commercial photoshoots and rental requests. A full report is attached. The pilot program revealed that the strongest public demand for tours is on Saturday, particularly from working families with children.

After a thorough evaluation of the information gathered during the pilot program, the Department recommends full implementation of the FSEIR, which was approved by your Board on August 12, 2014. Please let us know if you have any concerns. Otherwise, we will proceed with the implementation of the full FSEIR after 30 days, opening the gardens to the public each Saturday, thereby allowing more families from throughout the County to enjoy this beautiful garden.
