REPORT BACK ON MOSQUITO ABATEMENT (ITEM NO. 7, AGENDA OF AUGUST 19, 2014)

On August 19, 2014, a Motion by Supervisor Antonovich directed the Chief Executive Office's (CEO) Unincorporated Area Services Division to report back to the Board in two weeks on other communities in the County that have not been annexed into a mosquito abatement district and require corrective action.

The Department of Public Health, Environmental Health Division, which is responsible for mosquito and vector control issues in the County, has provided information on the attached chart (Attachment). The Attachment includes the communities that have not been annexed into a mosquito/vector control district, as well as their corresponding Supervisorial District, proposed mosquito/vector control district, and the Department of Public Health's recommended corrective action plan.
