## REQUEST FOR EXTENSION: FEASIBILITY ANALYSIS AND PRELIMINARY SPACE PLAN FOR RANCHO LOS AMIGOS SOUTH CAMPUS (ITEM NO. 89-B, AGENDA OF **NOVEMBER 18, 2014)**

On November 18, 2014, a motion by Supervisor Knabe instructed the Chief Executive Officer to report back in 90 days with a feasibility analysis and preliminary space plan for the properties at 9150 Imperial Highway in Downey, 1100 North Eastern Avenue in Los Angeles, and the Rancho Los Amigos South Campus (Rancho South Campus) in Downey, including cost information and any options that are cost-effective and consistent with the Facility Location Policy.

On March 5, 2015, a 90-day extension was requested to more fully evaluate potential departments for relocation to the Rancho South Campus and identify preliminary budget, To date, we have identified seven Departmental schedule, and financing schemes. Headquarters that could potentially relocate to the Rancho South Campus. We are requesting additional time to further develop the cost-benefit analysis to ensure that all cost impacts have been evaluated in order to provide a comprehensive proposal for the Board's consideration. Therefore, a 45-day extension to June 30, 2015 is requested for a report back on this item.
