**A RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE,  
REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF  
LOS ANGELES TO PERMIT THE REGISTRAR OF VOTERS OF SAID  
COUNTY TO RENDER SPECIFIED SERVICES TO SAID CITY  
RELATING TO THE CONDUCT OF A GENERAL MUNICIPAL  
ELECTION, CONSOLIDATED WITH THE GLENDALE UNIFIED SCHOOL  
DISTRICT AND THE GLENDALE COMMUNITY COLLEGE DISTRICT  
GOVERNING BOARD MEMBER ELECTIONS TO BE HELD IN SAID CITY ON  
APRIL 7, 2015**

WHEREAS, a General Municipal Election is to be held in the City of Glendale on April 7, 2015; and

WHEREAS, in the course of conduct of said election and in relation thereto, it is necessary for the City to request the services of the County; and

WHEREAS, all necessary expenses in performing this service shall be paid by the City of Glendale;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GLENDALE, CALIFORNIA, DOES RESOLVE, AND ORDER AS FOLLOWS:

SECTION 1. That pursuant to the provisions of § 10002 of the Elections Code of the State of California, this City Council hereby requests the Board of Supervisors of said County to permit the County Election Department to prepare and furnish the following for use in conducting said election:


1. A listing of county precincts with number of registered voters in each, so city may consolidate election precincts into city voting precincts, and maps of the voting precincts;
2. A list of polling places and poll workers the county uses for their elections;
3. The computer record of the names and address of all eligible registered voters in the City in order that the City's consultant may:
  - a. Produce labels for vote-by-mail voters;
  - b. Produce labels for sample ballot pamphlets;
  - c. Print Rosters of Voters and Street Indexes
4. Voter signature verification services as needed;
5. Make available to the City election equipment and assistance as needed according to state law.


SECTION 2. That said City shall reimburse said County for services performed when the work is completed and upon presentation to the City of the properly approved bill.

SECTION 3. That the City Clerk is hereby directed to forward without delay to said Board of Supervisors and to said Registrar of Voters, each a **certified copy** of this Resolution.

SECTION 4. That the City Clerk shall certify to the adoption of this Resolution.




