BOARD MOTION OF APRIL 7, 2015, AGENDA ITEM 4 SIERRA HIGHWAY AT EDUCATION HIGHWAY TRAFFIC SIGNAL CONTROLS UNINCORPORATED CANYON COUNTRY AREA

As directed by the Board, Public Works will be installing a traffic signal at the intersection of Sierra Highway and Education Highway (the entrance to Mint Canyon Elementary School) in the unincorporated Canyon Country area.

The total cost for the installation of the traffic signal is estimated to be \$350,000. The necessary \$15,000 to finance a portion of the design cost is available from the Highway Safety Projects appropriation of the Fifth Supervisorial District's Road Construction Program in the Road Fund Fiscal Year 2014-15 Budget. Funding for the remaining \$335,000 to finance the remaining design and construction costs can be made available in the Fifth Supervisorial District's Road Construction Program in the Road Fund Fiscal Years 2015-16 and 2016-17 Budgets. We anticipate construction to be completed by October 2016.

The Sulphur Springs School District and Mint Canyon Elementary School have expressed concern regarding traffic at the intersection of Sierra Highway and Educational Highway (the entrance to Mint Canyon Elem. School), during the school's arrival and dismissal times. Due to the high rate of motorist's speeds on Sierra Highway, it is difficult for parents to make left-hand turns from Educational Highway onto Sierra Highway. In order to address this concern and enhance traffic flow, traffic signals are needed at the subject location.

I, THEREFORE, MOVE that the Board of Supervisors direct the Director of Public Works to install a traffic signal at the intersection of Sierra Highway and Education Highway (the entrance to the Mint Canyon Elementary School) in the unincorporated Canyon Country area and report back to the Board of Supervisors within 30 days with a schedule to install and activate the traffic signal.
