


ANALYSIS

This ordinance amends Sections 2.82.020 and 2.82.050 of Title 2 - Administration of the Los Angeles County Code to require that the Sybil Brand Commission for Institutional Inspections conduct annual elections of a chair and vice chair and provide that commissioners be paid for their attendance at up to three commission-related activities per week, not to exceed \$150 per week.

ORDINANCE NO. 2015-0058

An ordinance amending Title 2 - Administration of the Los Angeles County Code, relating to elections of officers and compensation of commissioners serving on the Sybil Brand Commission.

The Board of Supervisors of the County of Los Angeles ordains as follows:

SECTION 1. Section 2.82.020 is hereby amended to read as follows:

2.82.020 - Composition.

A. The commission shall have 10 positions. A member of the commission shall be appointed to a vacant position by, and serve at the pleasure of, the board of supervisors, which shall be referred to in this chapter as the "board."

B. Each person who is a member of the commission on the effective date of the amendment codified in this section shall serve at the pleasure of the board for the remainder of his or her term of three years.

C. The commission shall annually elect a chair and vice chair from its members. The first election will take place within a month following the effective date of this amendment codified in this section. The elected chair and vice chair will serve from the date of the first election until December 31, 2016. Each election after the first election will be held at the end of the calendar year and the elected chair and vice-chair shall serve for a one-year term commencing January 1 and ending December 31 of the following year. The chair of the commission on the effective date of the amendment codified in this section may not be re-elected as officers in the first election held under this section.

D. The commission's bylaws shall include procedural guidelines relating to the election of officers, the method of voting, the establishment and structure of committees, and any other rules, procedures, and regulations the commission may desire.

SECTION 2. Section 2.82.050 is hereby amended to read as follows:

2.82.050 - Compensation.

Each member of the commission shall be paid, \$50 for attendance at each commission-related activity, not to exceed \$150 per week. Commission-related activities include attendance at commission meetings, inspections, and other activities approved by the presiding member at commission meetings, as stated in the commission's bylaws.~~each meeting of the commission attended by him, the compensation provided for him from time to time by the county salary ordinance. If no provisions for compensation are made in such salary ordinance, the members shall serve without compensation.~~
