<u>FACILITY/GROUP HOME INSPECTION REPORTS FROM DECEMBER 17, 2009</u> <u>TO JANUARY 5, 2010</u>

Temple Sheriff Station – Commissioners Bigby and Hill The facility was visited on December 18, 2009, and found to be in satisfactory condition.

Childs' Home for Children – 10, #3 – Commissioners Bigby and Hill The facility was visited on December 21, 2009, and found to be in unsatisfactory condition. Areas of Concern: The sink, blinds, dishwasher, screen door, hall wall paper, all the dresser drawers, and computer monitor need replacing. The windows, tile, oven, stove, and sliding glass door needs cleaning. The 1st Bedroom needs curtains or closet doors, the home needs more food and linen (sheets and towels), and the Fire Extinguisher needs servicing. A follow-up visit is planned in 30 days.

Children's Home of Southern California – 9, #2 – Chairperson Montaño The facility was visited on December 21, 2009 and found to be in satisfactory condition.

Santa Monica Branch Courthouse – Chairperson Montaño The facility was visited on December 22, 2009, and found to be in satisfactory condition.

Dangerfield Group Home III – 12, #2 – Vice Chairperson Bacio and Commissioners Hall and Moore The facility was visited on December 22, 2009, and found to be in satisfactory condition.

Children Are Our Future – 8, #4 – Commissioners Bigby and Hill The facility was visited on December 22, 2009, and found to be in unsatisfactory condition. Area of Concerns: No corrective action taken since the last visit on 11/20/09. Additional concerns are bedrooms 2 and 3 need new doors. Owner stated he never received the corrective action form from Lead Staff. A follow-up visit is planned on 1/22/10.
