I. ADMINISTRATIVE MATTERS

1. Meeting to be called to order by Chairperson Montaño. (11-4986)

**Chairperson Montaño called the meeting to order at 10:04 a.m.
Commissioner Moore joined the meeting at 10:10 a.m.**

Self introductions were made by those in attendance.

2. Approval of the November 2, 2011 Minutes. (11-4988)

3. ROUNDTABLE DISCUSSION

Department of Auditor-Controller

Department of Auditor-Controller's Office

Carla Carr, Group Home Ombudsman of the Auditor-Controller's Office, reported on two complaints filed by clients at Pennacle Group Home; she stated that she spoke with staff at Community Care Licensing (CCL) regarding the September 28, 2011 complaint filed against Pennacle Group Home "Corning Site" for the lack of supervision, and was informed that the allegation was substantiated on October 3, 2011. A Corrective Action Plan (CAP) was submitted by Pennacle Group Home, which includes retraining staff; the CAP approved by CCL on October 24, 2011. She stated that the results of the investigation into the September 27, 2011 complaint against Pennacle Group Home is forthcoming.

Department of Children and Family Services (DCFS)

Elizabeth Howard, CSA III, Department of Children and Family Services (DCFS), introduced Ms. Patricia Balonos-Gonzalez as the replacement for Ms. Dorothy Channel (Retired); she stated that Ms. Balonos-Gonzalez is an expert in developing group home programs, expansion of sites, and that she also collaborates with the State of California in developing their processes pertaining to group home licensing.

Ms. Howard, reported there were three referrals on Pennacle Group Home in June 2011, two were unfounded and one was deemed inconclusive. Ms. Howard explained that Group Homes are placed of Corrective Action Plans once the referrals are investigated and are deemed inconclusive.

Ms. Howard reported DCFS received a total of 46 Group Home referrals during the period of September 22, 2011 through November 15, 2011. There were 16 referrals in the category of Physical Abuse: one was unfounded, two were evaluated out to the appropriate departments for

investigation, and 13 remain pending. There were 22 referrals of General Neglect: One was unfounded, three were evaluated out to the appropriate departments for investigation and 18 remain pending; and there were six referrals of Sexual Abuse: two were evaluated out to the appropriate departments for investigation and four remain pending; one referral of Emotional Abuse which is pending and one referral for At-Risk which is pending. Ms. Howard also reported that during the same period there were 876 Runaways, DCFS is working with the Sheriff's Department, the Probation Department and other agencies in a collaborative effort to reduce and or prevent the number of Runaways incidents.

Following discussion, Ms. Balonos-Gonzalez agreed to provide the Commission with a copy of the current California Rate Increase Payment to Group Homes.

Internal Services Department

Mr. William Kiriya, Manager II, Maintenance Operations Division, Internal Service Department (ISD) will report back to the Commission his findings on the status of roof and tile repairs to be completed at Los Padrinos Juvenile Hall.

Department of Mental Health

There was no one present to speak before the Commission.

Probation Department

Ms. Pamela Pease, Acting Supervising Deputy Probation Officer of the Probation Department (PD), reported that currently no Group Homes are on hold. There were a total of 172 Absent Without Leave (AWOL) involving 171 different youths during the period of September 2011 through October 2011; 96 remain AWOL; five went to camp; 34 returned to Group Homes; 33 were placed in juvenile hall; one was placed on home probation; one was placed in a Soda Pad.

During the months of September and October 2011 there were six child abuse investigations, four were classified as unfounded, one was substantiated for general neglect and one is pending investigation. Additionally, there were 15 Group Home Monitoring investigations during the same period, six were substantiated, five were unfounded and four are pending investigation. In closing, Ms. Pease reported that staff at

Bayfront Group Home who allegedly restrained a youth in order to keep the youth from going AWOL, has been retrained on the best methods in handling difficult situations.

Sheriff's Department

Commander Asmus, Sheriff's Department, stated he would provide the presentation on behalf of Commander Cooper. Commander Asmus distributed a statistical report which details inmate assaults on inmates, inmate assaults on staff, and the use of force by Sheriff Deputies at County Jail Facilities. He noted that the Use of Force incidents declined during the month of October 2011, and that the controversies plaguing the Sheriff's Department, though problematic, may be a good thing, as they allow the department to be introspective and focus on solutions.

Commander Asmus stated that he was contacted by Judge Kline, Criminal Courts, regarding an inmate who was to be released from jail, who asked for an additional two weeks of jail time in order to complete the MERIT life skills program, which provides inmates alternative solutions in coping with challenging personal issues. Commander Asmus commented that the SMART program is positive and amazing.

Commander Asmus invited the Commission to the Sheriff Department's 23rd Annual 999 Christmas Celebration of the Department of Children and Family Services deaf and most fragile children, and their caregivers. The celebration will be held on Sunday, December 4, 2011 at the STAR Center in Whittier at 11:00 a.m. Additional information regarding the event will be forwarded to the Commission by Commander Asmus or a member of his staff.

Following discussion, Commissioner Moore requested that statistic reflecting the number of attempted suicides and actual suicide in County Jail Facilities is included in the Sheriff's monthly report to the Commission. Similarly, Commissioner Moore requested said information from Pamela Pease of the Probation Department; however, the report should include minor on minor assaults, minor assaults on staff and the use of force and disturbances involving probation department youths at group home facilities.

Vice Chairperson Bacio and Commissioner Moore visited Los Padrinos Juvenile Hall on November 15, 2011, and noted the roof has a serious leak and that there missing ceiling tiles in the girls' lock-up/dormitory.

Commissioners Hall and Moore visited Dangerfield Group Home #1 - 10 #4, on November 10, 2011.

Commissioners Bigby and Hill visited David & Margaret Home - 11 #4, on November 15, 2011.
