- **Commissioners Bigby and Hill visited Children Are Our Future "Harvey House" - 8 #2, on December 8, 2011. The Commissioners noted, the wooden edge on the kitchen rails near dishwahr were not repaired.**

7. Commissioners' Reports on Group Homes and/or Detention Facilities Inspections from December 8, 2011 to December 13, 2011. (11-5417)

During the reporting period the following Group Homes were reported as being in satisfactory condition:

- **Chairperson Montaño visited Project Six/Help Group - 36 #1, on December 13, 2011; and Olive Crest Treatment Center - 29 #4, on December 12, 2011.**
- **Vice Chairperson Bacio visited Eggleston Youth Center "Transitional House" - 15 #3, on December 13, 2011; and Eggleston Youth Center "Emancipation House" - 15 #2, on December 8, 2011.**
- **Commissioners Hall and Grills visited You Are The Difference Foundation "Loving Life Home II" - 45 #2, on December 8, 2011.**

During the reporting period the following Group Homes were reported as not being in satisfactory condition:

- **Commissioners Bigby and Hill visited Dubnoff Center "Valley Group Home" - 14 #3, on December 9, 2011, however, the facility was not inspected, as no one was home; the facility was revisited and inspected on December 13, 2011. The Commissioners noted that the facility was under new management, the Needs and Services Plans were not present. The Commissioners will revisit and inspect the facility in 30 days.**
- **Commissioners Hall and Grills visited Fred Jefferson Memorial Home "Compton House" - 19 #2, on December 13, 2011. The Commissioners will revisit and inspect Fred Jefferson Memorial Home "Compton House" in 30 days.**
