**Leslie Starr Heimov, Executive Director, Children's Law Center of California (CLC), provided an overview of their role in representing children in dependency court and a summary of current projects and services offered. Ms. Heimov responded to questions submitted by the Commission and listed impediments that prevent CLC from doing their job as attorneys in serving the children of Los Angeles County.**

**Judge Michael Nash, Los Angeles County Dependency Court, provided an overview on the court system's role in overseeing child welfare cases. Judge Nash shared his experiences with the court system and responded to questions posed by the Commission.**

**Laura Streimer, Legal Director and Angie Schwartz, Policy Director of the Alliance for Children's Rights, provided an overview of their services and expressed concern regarding the difference in benefits and services provided for children placed with non-relative caregivers in contrast to children in the custody of relative caregivers. Ms. Streimer and Ms. Schwartz responded to questions posed by the Commission.**

**Martha Matthews, Director of the Children's Rights Project, Public Counsel Law Center, provided an overview of the impact of funding in California and the combined impact of Title IV-E Waiver and Realignment at the State level. Ms. Matthews responded to questions submitted by the Commission and provided recommendations on how to improve the child welfare system.**

**Olivia G. Rodriguez, Executive Director, Los Angeles County Domestic Violence Council, presented an overview of their services and responded to questions posed by the Commission. At the request of the Commission, Ms. Rodriguez will provide the "Guidelines to Effective Response on Domestic Abuse" (GERDA) to Commission.**

**Members of the public, Arnold Sachs, Don Saxton, Patrick O'Rourke, Teresija Sigmund, Jordan Sigmund, Rodica Marinescu, Bill Gay, Lori Martin and Genie Briskin addressed the Commission.**
