AMENDMENT NO. 4 TO LEASE NO. 5574 PARCEL NO. 10 - MARINA DEL REY

THIS AMENDMENT TO LEASE made this 18th day of July

BY AND BETWEEN

COUNTY OF LOS ANGELES, hereinafter referred to as "County",

AND

1972,

NEPTUNE MARINA, a limited partnership, hereinafter referred to as "Lessee",

WITNESSETH:

WHEREAS, the predecessors in interest of Lessee and County entered into a lease and agreement on May 4, 1962, under the terms of which County leased that certain real property located in the Marina Del Rey and known as Parcel 10; and

WHEREAS, actual uses of the leasehold provided in Section 3 (Purpose or Use of Property) of said lease and agreement are not already defined; and

WHEREAS, it is the desire of both parties to amend said lease clarifying the permitted uses;

NOW, THEREFORE, in consideration of the mutual agreements, covenants and conditions contained hereinbelow, the parties and each of them do agree as follows:

1. Section 3 (Purpose or Use of Property) of said lease is hereby amended by deleting the first paragraph thereof and substituting the following therefor:

"The leased premises shall be used only and exclusively for apartments and anchorages and related uses such as a restaurant, and other such related uses and purposes incidental thereto as are specifically approved and for no other purposes whatsoever without the written approval of County; the uses and purposes above listed are set forth to define the maximum contemplated scope of permissible

uses and purposes, and their enumeration is not intended to be authorization for any specific purpose."

2. Any and all other terms and conditions in the present lease and all amendments thereto are hereby reaffirmed and shall remain unaffected and in full force during the term of the agreement and any extension thereof.

IN WITNESS WHEREOF, THE COUNTY OF LOS ANGELES, by order of its Board of Supervisors, has caused this amendment to lease to be executed on its behalf by the Chairman of said Board and attested by the Executive Officer-Clerk thereof, and the Lessee has executed the amendment to lease, or caused it to be duly executed.
