## AMENDMENT TO LEASE

THIS AMENDMENT TO LEASE made this 17th
day of FEBRUARY , 19 64, by and between the County of
Los Angeles hereinafter referred to as "County" and Jona Goldrich,
Sol Kest, Albert C. Black, Marvin David Miller, Joint Venturers
hereinafter referred to as "Lessee" WITNESSETH:
WHEREAS, the parties hereto have heretofore, on the
twenty-first day of December , 1962, entered
into a lease of premises, commonly referred to as Parcel or
Parcels Number Twelve (12) , Marina del Rey,
consisting of a total of 538,696 square feet and
situated in the Marina del Rey Small Craft Harbor of the County
of Los Angeles, State of California, more particularly described
in Exhibit "A" attached hereto and incorporated herein, and;
WHEREAS, the Board of Supervisors on the twenty-eighth
day of August, 1963 adopted a resolution autho-
rizing certain amendments to the provisions of the said lease:
NOW, THEREFORE, in consideration of the mutual premise
and covenants of each of the parties hereto, it is hereby agreed
as follows:
1. SECTION 18 (DISPOSITION OF INSTALLATIONS OR IMPROVEMENTS) IS HEREBY AMENDED BY ADDING THE FOLLOWING SENTENCE AFTER THE WORD "THEREOF" AT THE END OF THE FIRST PARAGRAPH OF SAID SECTION:

Nothing contained herein shall be construed to deny or abrogate the right of Lessee to receive any and all proceeds which are attributable to the taking in eminent domain of

business installations, improvements, structures and buildings belonging to Lessee immediately prior to the taking of possession by the condemning authority as said rights are

set forth in Section 43 of said lease.

  Structures, buildings, or other improvements belonging to Lessee immediately prior to the taking of possession
- All other terms and conditions and covenants to the said lease are to remain unchanged.
