
eConsult update!

eConsult has now expanded to 24 specialty services with the recent addition of Infectious Disease, HIV Services, Oncology, Orthopaedic Surgery, Physical Medicine and Rehabilitation, Physical Therapy, Occupational Therapy and Speech Therapy. We expect to see additional surgical specialties come on board in late May – more progress toward our goal of bringing all specialties onto eConsult. By the numbers....
