MENTAL HEALTH SERVICES ACT (MHSA) PROPOSED MHSA HOUSING PROGRAM CAROLINE SEVERANCE MANOR CAPITAL DEVELOPMENT PROJECT

The Los Angeles County Department of Mental Health (LACDMH), as required under the Mental Health Services Act (MHSA), is opening a public review and comment period for the proposal submitted by Mercy Housing California, Project Sponsors of the Caroline Severance Manor Project proposed to be funded through the MHSA Housing Program. Through the MHSA Housing Program, LACDMH was allocated \$115,571,200 for capital development and capitalized operational subsidies for permanent supportive housing for individuals with psychiatric disabilities and their families. As required by the program, the funds were transferred to California Housing Finance Agency (CalHFA), who will administer the funds and underwrite the loans. The project is located in Service Area 4 and Supervisorial District 2 and will target homeless adults to occupy 30 one bedroom units and children as the MHSA eligible tenant and their families will occupy 18 multi bedroom units. They are requesting a MHSA Capital Development loan of \$5,031,840 and \$4,516,800 for Operating Subsidies for the 48 MHSA funded units, of an 85 unit project, which will be dedicated to individuals with psychiatric disability.

The public review and comment period will run from May 26, 2009 through June 26, 2009.
