## The Kaiser Permanente Child Health Plan (KPCHP) Open Enrollment in Southern California

Effective October 11, 2011, the Kaiser Permanente Child Health Plan (KPCHP) will temporarily reopen for enrollment in Los Angeles County, Orange County and San Diego County.

Depending on the family's size and income, up to three children per family can receive heath care coverage for \$8 or \$15 a month, per child. Additional children are covered at no extra premium. Comprehensive healthcare services include medical office visits, medical tests, vision services, <u>mental health services</u>, substance abuse services, health education, hospital services, and prescription drugs.

KPCHP covers documented and undocumented children (0-18) with a family income between 0 - 300% of the Federal Income Guidelines (FIG):
