Beginning in April, changes will go into effect that will bring the Integrated System (IS) into compliance with the standardized electronic transaction requirements of the Health Insurance Portability and Accountability Act of 1996 (HIPAA). Changes have been made to the IS that impact what providers report on several screens for outpatient, day treatment, and inpatient providers. The Chief Information Office Bureau (CIOB), Quality Assurance (QA) Division, and Revenue Management Division (RMD) staff are offering regional training sessions March 5-8, 2012 plus a training on March 15th exclusively for inpatient and residential providers. Below is the schedule with training dates, locations, and times. Space is extremely limited and we expect each session will be full. Providers should only attend one session. Only those people who are involved in data entry or billing should attend one of the sessions identified below.
