For example, "PENDING CPE" claims accepted by the IS on July 2, 2013 (cutoff date for EDI is July 4, 2013 and for DDE is July 5, 2013) may not be included in the payment report for the anticipated August 1, 2013 warrant. In such case, these claims will be included in the next payment report for the September 3, 2013 warrant.
