ABOUT CPTNP

- One of six projects in MHSA Information Technology Plan
- Over \$22 million allocated to 120 Legal Entities (LE) to offset Contractor costs for:
 - Electronic Health Record systems
 - Electronic Data Interchange (EDI) with DMH
- Other non-EDI projects permitted for those who achieved EDI
- Reserve of over \$1M set aside for new LEs who join DMH in advance of IBHIS





ABOUT CPTNP

- Contractors required to submit IT project proposals to describe use of CPTNP funds
- Proposal process took over 3 months on average
- Contract process took an additional month
- First proposal submitted January 2009
- First Technological Needs Funding Agreement (TNFA) executed April 2010






ABOUT CPTNP

- LEs were slow to apply for funding
- Concern that LEs who delayed applying for funds may not be ready for EDI to IBHIS on July 1, 2014
- To facilitate contractor readiness for IBHIS DMH established a March 1, 2013 deadline for proposal submission
- About half of eligible LEs delayed submission until just before the deadline

CURRENT STATUS

- 105 TNFAs fully executed
- 13 Pending execution
- 2 Project proposals pending (LEs newly added)
- Proposal review staff reassigned to other CIOB projects

REALLOCATION OF RESERVE

- A portion of the Reserve will be kept as CPTNP Reserve
 - Used as small grants at \$10,000 each to any Healthy Way LA Community Partner agencies who become DMH Legal Entities in 2014
 - UCLA Ties for Adoption
- Remainder will be transferred to the IBHIS Project
