For example, "PENDING CPE" claims accepted by the IS on June 30, 2015 (cutoff date for EDI is July 2, 2015 and for DDE is July 3, 2015) may not be included in the payment report for the anticipated July 31, 2015 warrant. In such case, these claims will be included in the next payment report for the September 2, 2015 warrant.

\*\*In order to be included and/or considered, all claims must be entered on or before end of the business day at 5:00pm, on all the deadlines listed above.
