County of Los Angeles

The five-member Board of Supervisors is the governing body of the County of Los Angeles. As a subdivision of the state, the County is charged with providing numerous services that affect the lives of all residents, including law enforcement, property assessment, tax collection, public health protection, public social services, elections and flood control. The County also provides municipal services to all 88 cities in Los Angeles County in varying degrees under contract with their city councils. The Board of Supervisors acts as the "city council" for the approximately 1 million residents living in unincorporated areas, which is about 65 percent of the land area of the County.

- Los Angeles County is one of the nation's largest counties with 4,084 square miles and its 10.4 million residents make it the most populated.
- Almost 30 percent of California's residents live here.
- If it were a nation, it would have the 19th largest economy in the world.
- Property valuation for 2009-10 is \$1.12 trillion.
- It is the nation's top international trade center, largest manufacturing center, and aerospace research/development capital.
- The County's \$23.175 billion budget provides for 100,364 employees, making it the largest employer in the five-county region.
