
Gentlemen:

REPORT DIGEST

DEPARTMENT OF CORONER - ANNUAL REPORT 1955-56

The Coroner's Department had a caseload of 9450 cases for the fiscal year 1955-56, which shows an increase of 816 over the previous year.

A breakdown of this total is as follows:

Deaths due to natural causes	5900
Due to traffic	927
Due to suicides	753
Due to homicides	193
Due to industrial accidents	147
Due to home accidents	949

Of the 927 traffic fatalities 326 were pedestrian, 136 of which were over 65 years of age. 175 of these pedestrian deaths occurred at an intersection.

There were 601 collision and non-collision accidental deaths in motor vehicles, 485 of which were over 20 years of age.

7 persons lost their lives through electric railway accidents and 42 through steam railway accidents.

Of the 193 homicides, 114 were in the age group of 20 to 45 years of age. 64 of the homicide deaths were the result of altercations.

Of the 753 suicides, 262 were the result of ill health.

4669 autopsies were performed of the 9450 cases processed by the Coroner during the year. 7984 microscopic examinations were made in the pathological laboratory.

417 inquests were held during the year.

The Department's total expenditure during 1955-56 was \$421,015.27 comprised as follows: Salaries and Wages, \$373,235.95; Maintenance and Operation, \$41,113.78 and Capital Outlay \$6665.54.

Revenues collected for the fiscal year 1955-56 were \$78,643.75.
