### **AGRICULTURAL OPERATOR IDENTIFICATION NUMBER HOLDERS** **(Excluding Restricted Materials Permit Holders)**

**If you possess a 2020 Operator Identification Number, please note that it will expire December 31, 2020.**

If you plan to apply pesticides at an agricultural production or non-production site(s), such as parks, cemeteries, golf courses, utility right-of-ways, or certain non-agricultural sites, you are required to obtain an Operator Identification Number from the Agricultural Commissioner prior to the purchase and use of those pesticides.

**Please note that all county offices are closed to the public until further notice.**
