

## AGRICULTURAL PEST CONTROL ADVISER 2021 REGISTRATION INFORMATION

---

### LICENSED PEST CONTROL ADVISER (PCA)

The California Food and Agricultural Code states: "No person shall act, or offer to act, as an Agricultural Pest Control Adviser without first registering with the County Agricultural Commissioner." It further requires that an adviser register first in their "home" county, then other counties of "occupational choice." If you plan to act as a pest control adviser anywhere in California and the address on your card is in Los Angeles County, you must register with us first.

### REGISTRATION PROCESS

Advisers register by mail. Mail the completed form, copy of your PCA card, and registration fee to the Agricultural Commissioner/Weights and Measures 12300 Lower Azusa Road, Arcadia, CA 91006. **'Home County' is determined by the address listed on your PCA card.**

**Note: Due to the pandemic our office is closed to the public until further notice.**

Please provide the following information on the enclosed form.

#### **Home County Registration**

- A legible photocopy (front and back) of your valid 2021 Adviser's Card.
- \$10.00 Registration Fee.
- Verification on registration card of the location at which you maintain copies of your written recommendations.

#### **Out of County Registration – (By mail)**

- An Agricultural Pest Control Adviser County Registration Form. This form should be obtained from and printed by your home county. Be sure to complete the entire form.
- \$5.00 Registration Fee.
- Verification on registration form of the location at which you maintain copies of your written recommendations.

#### **FEE**

Registrations will not be processed if not accompanied by the required fee. A registration fee of **\$10.00 for Home County** and **\$5.00 for Out of County** registrations is required for all Agricultural Pest Control Advisers. **Make check or money order payable to "LA County, Agric Comm/Wts & Meas"**. Do not send cash.
