In order to bring your property into compliance with the Fire Code and avoid possible legal action, you must perform the following checked item(s) by **August 25, 2014**.

1. Clear, cut back, thin out, trim up, and remove flammable vegetation or combustible growth for a distance of **100** feet from any structure (even if the structure is not on your property) so as to create a firebreak. This section shall not apply to single specimens of either native or ornamental trees, shrubs or ground covers provided they are cut back, thinned out, trimmed up and spaced so as to provide an adequate firebreak and do not form a fuel ladder to any structure. In areas of erosion, it is recommended that roots of cut weeds and brush not be disturbed.
2. Roadways: Clear and remove all flammable or combustible growth for a minimum of 10 feet on each side of every roadway whether public or private.
3. Other: **Clear, cut back, thin out, trim up, and remove flammable vegetation or combustible growth on slope for a distance of 100 feet around any structure.**
