REPORT BACK ON LAUNCHING A “WORKER OWNERSHIP INITIATIVE” TO BUILD WEALTH, RETAIN QUALITY JOBS, AND STABILIZE BUSINESSES MOTION (ITEM NO. 8, AGENDA OF SEPTEMBER 12, 2023)

On September 12, 2023, your Board approved a motion titled Launching a “Worker Ownership Initiative” to Build Wealth, Retain Quality Jobs, and Stabilize Businesses ([Motion](#)). The Worker Ownership Initiative (WOI) takes a holistic, ecosystem-building approach to scaling employee ownership as part of an ongoing effort to address inequities across the County. Through this initiative the County seeks to embrace an innovative economic development of broad-based worker ownership as a means of retaining local businesses and increasing workers’ economic security through a combined quality jobs and asset building (profit-sharing, retirement savings, and shared business ownership). The Motion instructed the Internal Services Department (ISD), in partnership with the Department of Economic Opportunity (DEO) to report back to your Board in 90 days on the following:

Direct the Director of ISD through the Office of Strategic Contracting Equity, in partnership with the Director of DEO, to report back to the Board in writing in 90 days with an analysis of the County’s procurement trends, a forecast of future procurement needs, and recommendations on opportunities to align targeted worker ownership industry engagement and development with the County’s procurement needs. The report should also include an analysis and recommendations on other potential procurement incentives and strategies that the County could implement to invest in and support worker-owned businesses.

ISD established a “Workgroup” comprised of ISD representatives, County Counsel, and the DEO who met on a regular basis to address the directive outlined in the Motion, specifically, to provide the County’s procurement trends, a forecast of future procurement needs, and recommendations and potential procurement incentives and strategies to support the WOI. This report back addresses the specific Board directive indicated above.

Background:

While the County has taken initial steps, there is an opportunity for deeper and more strategic investment in this strategy. The County can launch a WOI that takes a holistic, ecosystem-building approach to scaling employee ownership across the County. The County can lead a WOI and can coordinate with local stakeholders, including technical providers, worker centers, and business advisors to potentially integrate WOI technical assistance into the County’s existing small business and workforce development programs and services to support worker-owned businesses.

County Procurement Trends

To adequately provide the County procurement trends, ISD conducted an extraction of procurement expenditures in eCAPS made in Fiscal Year 2022-23. Based on this data, ISD has developed a County Procurement Trends Report (Attachment 1) which is categorized using the financial data fields available (and data entered) in eCAPS. The workgroup recommends that this historical data and it’s the corresponding data categories be used by the County to (i) strategically conduct outreach to worker-owned firms in these categories to encourage them to register to do business with the County, (ii) certify worker-owned businesses in these categories under the new Social Enterprise (SE) designation, (iii) advertise solicitations and maximize solicitation competition in these categories to worker-owned businesses, and (iv) overall, increase the County’s diversity of its supplier pool.

Forecast of Future Procurement Needs

To properly address the Board Motion directive, ISD surveyed all County departments on upcoming County purchasing and contracting opportunities planned to be released/conducted in Fiscal Year 2024-25. The purpose of the survey was to determine the County’s future procurement needs and develop potential recommendations to align the County’s procurement needs with the Motion objectives.

Survey Results

In October 2023, ISD disseminated a survey that was developed by the stakeholders listed above (“the Workgroup”). The survey was sent to 39 County departments, and 29 department responses were received as indicated and summarized in Attachment 2. Of the responses received by the 29 departments, 19 departments indicated they intend to release one or more solicitations between July 2024 – June 2025.

Recommendations on Opportunities to Align the Worker Ownership Industry Engagement and Development with the County’s Procurement Needs

The Workgroup (comprised of ISD representatives, County Counsel, and the DEO) recommends using a strategic approach that benefits both the business and the worker owners when aligning worker-ownership opportunities with the County’s procurement needs using the following methods:

- Expanding the County’s Preference Program: Los Angeles County Code (LACC) Chapter 2.205 – Social Enterprise Preference Program to ensure worker-ownership business models qualify as a SE and are eligible to receive a 15% preference when bidding on certain goods and service solicitations. The LACC amendment demonstrates the County’s commitment to supporting worker-owned businesses by adding a new worker-ownership designation into the SE Preference Program (diversity) and integrates it into the County’s procurement process.
- Identify Worker-Owned Businesses and Goals: Identify worker-owned businesses, understand any constraints. DEO can create a distribution list to conduct outreach to SEs to advertise County solicitations; Market worker-owned businesses to each specific County spend category (target outreach to recruit a sufficient vendor pool based on County needs) and make County solicitations accessible and inclusive to those firms.
- Networking and Outreach: Actively engage with worker-owned businesses through networking events, vendor events, and on the County’s websites (Doing Business with and Department of Consumer and Business Affairs (DCBA)).
- Train Procurement Staff: Ensure County procurement teams are knowledgeable about worker-owned businesses, their unique structures, and the benefits of engaging with them. This education can help remove biases and misconceptions. It will also inform procurement staff of potential solicitation strategies to include worker-owned businesses.
- Evaluations: When evaluating proposals, include evaluation criteria for worker-owned businesses when firms subcontract portions of eligible work to worker-owned businesses and apply a 15% preference to worker-owned businesses that are certified under the County’s SE program when such firms submit bids/proposals.

Other Potential Procurement Incentives and Strategies

To properly address the Board motion directive, ISD researched worker-ownership procurement incentives, models, and initiatives enacted by other municipalities and found a range of incentives and programs. The following 12 municipalities were contacted to seek best practices on potential procurement incentives and strategies that the County could implement to invest in and support worker-owned businesses:

- Chicago: Provides technical and professional assistance to already existing, about-to exist, or yet-to-exist cooperatives through 17 organizations (non-profits and/or Community Based Organizations that make up the Community Wealth Building (CWB) Initiative funded via American Rescue Plan Act (ARPA) funds. Chicago also provides up to \$150,000 in planning and pre-development grants (funded through ARPA-total of \$4 million) to assist businesses in transitioning.
- Colorado: Through its Office of Economic Development, and International Employee Ownership Office, provides free online courses (options and benefits) and legal support; partners with providers to provide guidance to interested businesses. Additionally, the Employee Ownership Tax Credit covers up to \$25,000 of conversion costs for worker-owned cooperatives and employee ownership trusts or \$100,000 of conversion costs for employee stock ownership plans on a business' state income taxes. The Employee Ownership Grant provides funds to offset transition professional technical service costs for Colorado businesses converting to an employee ownership structure.
- Massachusetts: Through a contracted vendor, provides education and awareness, feasibility analysis, outreach, and connection to service providers (legal support). Massachusetts also connects business with programs offering grants, and loan subsidies.
- Iowa: Partners with Iowa Center for Employee Ownership to provide education and awareness, and technical support through annual state funding. Legal services, financing, assessments, and modeling are provided through partnerships with organizations. Iowa provides Employee Stock Ownership Plan (ESOP) Formation Assistance, which provides for up to 50% of costs for a feasibility study (not to exceed \$25,000) for businesses interested in converting to an ESOP; 50% deduction from state income taxes for the net gain from the sale of stock to an ESOP; and potential qualification for 1042 deferral of capital gains for the selling owner (Federal).
- Missouri: Provides Business outreach (education) and resources (e.g., list of service providers who can assist with employee ownership transition) through a partnership with Missouri Center for Employee Ownership. Additionally, Missouri offers 50% income tax deduction on the proceeds business owners receive when they sell their companies to their employees.

- New York (NY): Contracts with 14 organizations to provide technical assistance (TA), education, legal services, and financing to develop worker-owned businesses (Worker Cooperative Business Development Initiative partners received a total of \$3.818 million in Fiscal Year 2022). Through legislation, NY offer deductions and tax benefits, and improved access to capital (loans) for small businesses looking to transition.
- North Carolina: Independent non-profits (North Carolina Employee Ownership Center, Carolina Common Enterprise, and The Industrial Commons) provide open book management, business succession, and legal support (funded through grants and donations, and contracts with individual municipalities).
- San Francisco: Grantees receive support and TA but all established cooperatives obtained development guidance and TA from outside provider. Does not provide specific financial assistance to worker-owned businesses; however, one vendor received funding through an RFP.
- Vermont: Provides education, outreach, and TA to businesses transitioning to worker cooperatives (provided by VEOC, a non-profit agency).

The following Counties do not have any worker ownership initiatives in place:

- Riverside County
- San Diego County
- Orange County

The Workgroup (comprised of ISD representatives, County Counsel, and the DEO) is recommending the following procurement incentives and strategies:

Amendment of LACC Chapter 2.205 – Social Enterprise Preference Program

The workgroup fully supports and recommends the amendment of LACC Chapter 2.205 – Social Enterprise Preference Program to ensure worker-ownership business models qualify as a SE and are eligible to receive a 15% preference when bidding on certain goods and service solicitations. The amendment of LACC Chapter 2.205 will additionally enable worker-ownership models to qualify for certain procurement opportunities not otherwise available to non-SEs, including DEO's Social Enterprise Master Agreement, and potentially, contract advances.

Amendment of LACC Chapter 2.213 Business Utilization Goals

The County's Preference Program Enterprises (PPEs) consists of three designations, Local Small Business Enterprises (LSBEs), Disabled Veteran Business Enterprises (DVBES), and SEs. The workgroup recommends an amendment to the Administration of the Los Angeles County Code Chapter 2.213 Business Utilization Goals to set a 2% Countywide Social Enterprise utilization goal. This recommendation aligns with the

existing 25% utilization goal for LSBE's and 3% utilization goal for DVBES. This recommendation will result in establishing utilization goals for each designation under the County's PPE Program.

Encourage Subcontracting with Worker-Ownership Businesses

ISD will encourage subcontracting with worker-ownership businesses by issuing contracting guidelines for departments to consider (as deemed appropriate by each contracting department issuing a service solicitation in which factors other than cost are evaluated) the inclusion of an evaluation component that considers whether proposers will subcontract portions of eligible work to worker-owned businesses ((and/or other SEs, LSBEs, and/or DVBES, collectively, PPEs. ISD will revise its model solicitation documents to encourage subcontracting with worker-owned businesses by including a "Subcontracting with PPEs" evaluation component for department consideration and will incorporate this recommendation in its trainings to departments.

Technical Assistance Provided through DEO

Technical assistance can be instrumental in helping businesses transition to an employee ownership structure. Based on the research conducted, many municipalities are providing some form of technical assistance to businesses looking to transition, which can also be best practices for the County. As such, the DEO can provide technical assistance and general guidance to businesses interested in converting to an employee ownership structure. The workgroup recommends the following technical assistance:

- **Transition Planning:** This assistance can help create a detailed transition plan that outlines the steps, timeline, and responsibilities for the worker-owned conversions, which can help minimize disruptions and ensure a smooth transition.
- **Employee Education:** Providing education and training to employees is key in an employee ownership transition. Technical assistance to worker-owned businesses, or businesses interested in transitioning, can help businesses develop programs to help employees understand the benefits and responsibilities of ownership.
- **Governance and Management:** Assistance may be required to establish governance structures and management systems that empower employees to actively participate in decision-making processes.
- **Communication Strategies:** Effective communication is essential to gain employee buy-in and support for the ownership transition. County assistance can be provided on designing communication strategies to keep employees informed and engaged.

- Sustainability Planning: Ensuring the long-term success of the employee-owned business is critical. County provided sustainability technical assistance can aid in developing strategies for growth, profitability, and ongoing employee involvement in the businesses.

In summary, technical assistance can offer valuable expertise and guidance to businesses looking to convert to an employee ownership structure, facilitating a smoother transition and ensuring the long-term success of the employee-owned venture.
