REQUEST FOR MANAGEMENT APPRAISAL AND PERFORMANCE PLAN SALARY PLACEMENT FOR PETER LOO UPON APPOINTMENT TO THE POSITION OF CHIEF INFORMATION OFFICER (UC)

The Chief Executive Officer requests approval to appoint Mr. Peter Loo to the position of Chief Information Officer, Item No. 2580, at an annual base salary of \$333,757. This notification is required because the base salary placement onto MAPP, Tier I, Salary Range R17, (Board approved range for this position), will place Mr. Loo above the control point of the range and the salary threshold per County Code Section 6.08.370C, which is currently set at \$213,000. This salary is recommended based on Mr. Loo's extensive experience and the role he will perform as the Chief Information Officer (CIO).

Mr. Loo will report to the executive over the Policy Implementation and Alignment Branch wherein he will serve as chief technology adviser to County departments. He will play a critical role in the conceptualization and implementation of the County's strategic goals related to technology. He will also play an integral role in the implementation of information technology policies and directives as well as the development of solutions and platforms to meet the current and anticipated needs of the County.

Mr. Loo is a seasoned professional with over 30 years of public sector IT experience. Since 2012, Mr. Loo has served as Chief Deputy Director, CIO for Los Angeles County and for the last three years he served as acting CIO where he provides strategy, leadership and guidance on enterprise IT initiatives, IT Governance and the delivery of information technology capabilities to support the County mission. From 2006 through 2012, he served as Senior IT Consultant, CIO where he managed a countywide e-Government Program that directed the implementation of a countywide shared portal infrastructure. In that capacity, he also performed budget reviews and IT project and program oversight for the Sheriff's Department and Information Systems Advisory Body.

Mr. Loo possesses a Bachelor of Science degree in Chemical Engineering and a Master of Business Administration from University of California, Los Angeles.

In accordance with current practices on managerial appointments, unless otherwise instructed by the Board by June 25, 2024, the CEO will proceed with Mr. Loo's formal appointment to Chief Information Officer, at an annual base salary of \$333,757 effective no sooner than June 26, 2024.
