BOARD NOTIFICATION MONTHLY CHANGE ORDER REPORT HARBOR-UCLA MEDICAL CENTER REPLACEMENT PROGRAM DECEMBER 2024

As instructed in a Board Memo dated February 8, 2022, we are providing our monthly change order report for the Harbor-UCLA Medical Center Replacement Program pursuant to Public Contract Code Section 20142, which permits delegated authority to execute change orders up to \$750,000 for projects whose original contract value exceeds \$50,000,000.

The increased authority is subject to the limit that the aggregate of all such change orders executed under delegated authority shall not exceed 25 percent of the original contract amount as set forth in Public Contract Code Section 20145.

There were 14 change orders executed under my delegated authority in the month of December 2024 for the Harbor-UCLA Medical Center Replacement Program (see attached).
