PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The Operational Area Emergency Response Plan (OAERP) is a strategic and policy-level plan that establishes the Operational Area's (OA) emergency organization, identifies departmental responsibilities, and specifies policies and general procedures for addressing emergencies impacting the OA – both in the urban and unincorporated areas. The Chief Executive Office, Office of Emergency Management (OEM) developed the OAERP with input from County departments, Disaster Management Area Coordinators, and subject matter experts.

The California Emergency Services Act (ESA) requires local emergency planning and plans to be coordinated with the State Emergency Plan. County Code 2.68 directs the OEM to develop emergency plans. This plan is developed in accordance with the requirements of the ESA, the State's Standardized Emergency Management System (SEMS), and the Federal National Incident Management System (NIMS). These requirements are also necessary to ensure OA resources are integrated into an efficient organization capable of responding to all natural and man-made emergencies. It is essential that we meet these requirements to qualify for State and Federal emergency management and Homeland Security grants and possible State recovery program assistance in a state proclaimed emergency or federally declared emergency/disaster.

The OAERP is compliant with the National Response Framework, consistent with the 52 critical elements of the State's SEMS issued by the California Emergency Management Agency (Cal EMA), and follows the principles of the Incident Command System (ICS).

IMPLEMENTATION OF STRATEGIC PLAN GOALS

Approval of this plan is consistent with the County's Strategic Plan Goal 3 - Integrated Services Delivery: Maximize opportunities to measurably improve client and community outcomes and leverage resources through the continuous integration of health, community, and public safety services.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

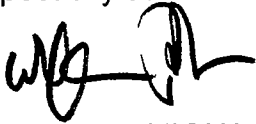

PROJECT SUMMARY

With a large urban population and vulnerability to a wide range of disasters, the Los Angeles County Operational Area's long-standing commitment to emergency planning plays a significant role on our approach to ensure the most effective preparedness, response and recovery efforts for the maximum benefit and protection of the public in time of emergency.

The Operational Area Emergency Response Plan (OAERP) is a strategic and policy level document that establishes the Operational Area (OA) emergency organization, identifies departmental responsibilities, and specifies policies and general procedures for addressing emergencies impacting the OA – both urban and unincorporated areas. This plan also provides for the coordination of emergency operations plans of county departments, cities, special districts, agencies and unincorporated areas.

In accordance with County Emergency Ordinance 2.68, the Office of Emergency Management (OEM) has been tasked with the responsibility for updating, developing and maintaining the OAERP. The intent of this plan is to integrate OA resources into an efficient organization capable of responding to any emergency using the National Incident Management System (NIMS), Standardized Emergency Management System (SEMS), mutual aid and other appropriate response procedures.

OEM has taken the lead in facilitating the development of this important plan. OEM created the Operational Area Emergency Response Plan Working Group that consists of representatives from OEM and:

PLAN DEVELOPMENT

OEM began plan development in June/2010. To ensure agency and jurisdiction involvement and collaboration, an OAERP Working Group was created consisting of OEM, Emergency Management Council (EMC) Subcommittee members and the Disaster Management Area Coordinators (DMACs). The Working Group based its work on a draft provided by OEM and have worked through a long and rigorous process to create this final draft plan.

Compliance

This draft document is compliant with the National Response Framework (NFR), consistent with the 52 critical elements of California's Standardized Emergency Management System (SEMS) issued by California Emergency Management Agency (Cal EMA), and the follows the principles of the Incident Command System (ICS). This document is also compliant with existing Los Angeles County Office of Emergency Management disaster policies. The Operational Area Advisory Board (OAAB) and EMC Subcommittee has reviewed and accepted the plan. Cal EMA has reviewed this draft document and has determined the OAERP is acceptable and in accordance with the requirements of the Emergency Services Act and SEMS.

Plan Components

The Basic Plan:

Describes in general terms the emergency management organizational and operational concepts relative to response and short-term recovery activities. This includes Incident Command System–based role assignments and organization during a disaster, a matrix of organizations, and primary and supporting roles and responsibilities (including functions).

Appendices:

Provides additional pertinent information including: a glossary of terms, acronyms, legal and supporting documents, specific hazards, OAERP plan structure, documents that emphasize responsibilities, tasks and operational actions for coordinating resource and support.

Functional Annexes:

Explains how the OA will carry out broad functions in an emergency. When applicable, these functional annexes describe the role of various agencies in support of this plan. Currently approved functional annexes include Animal response, Family Assistance,

Donations, Repatriation, Topanga Evacuation Plan, Unincorporated Areas, and Volunteer Plan Annex.

Hazard-Specific Annexes:

Focuses on specific hazards that impact the OA, including urban and unincorporated areas and provides additional guidance for response and recovery operations for those hazards. Typically, these specific hazards have been identified as “high-risk” in the OA All Hazards Mitigation Plan. Individual agencies/jurisdictions have SOPs and annexes identifying its response actions to each specific hazard.

PLAN COORDINATION

Operational Area Emergency Response Plan Working Group (OAERPWG)

The OAERPWG plan development supports the mission of the Emergency Management Council Sub Committee and the Operational Area Advisory Board (OAAB) and Operational Area Response and Recovery Steering Committee (OSC). The EMC Sub Committee, OAAB and OSC missions are:

Emergency Management Council Sub Committee

The EMC established the Subcommittee to assist the EMC, Steering Committee, and OEM in developing emergency plans.

Operational Area Advisory Board

The mission of the OAAB is to provide a forum for emergency response partners to cooperatively work together to address issues affecting the planning, response and recovery to disasters in the OA.

Operational Area Response and Recovery Steering Committee (OSC)

The OSC is a subcommittee of the OAAB and defines policy and develops procedures to support the County Emergency Operations Center/Operational Area Emergency Operations Center (CEOC/OAEOC) Standard Operations Procedures (SOP) and the Operational Area Emergency Response Plan (OAERP) and its annexes and advocate for end users.
