To the Los Angeles Sheriff Civilian Oversight Commission,

I am writing with urgent concern regarding a severe issue overlooked by the Los Angeles County Sheriff's Department (LASD). This concern involves a severe misuse of authority by an LASD captain who unlawfully removed our child from the missing person's list and facilitated the child's stay at the residence of a deputy with whom he had a personal relationship outside of our marriage. Despite presenting irrefutable evidence of my legal custodial rights over the child at the time, my complaints have been continuously ignored.

The captain at the center of this controversy is known to have ties with the "Lennox Reaper Gang," a connection to be inherited from his father, who has the 'number 1' tattoo of the Reaper on his ankle. His father started the Gang and raised serious questions about his integrity and the likelihood of biased enforcement actions, seeing the long history of gangs within the department, and most of them are upper echelons within the department. My complaint's investigation, conducted by a lieutenant rather than a higher-ranking official, directly contradicts department policies. The lieutenant's history as a deputy at the Lennox Station, where the captain has significant connections, casts doubt on the objectivity of the inquiry.

My efforts to communicate with my assigned point of contact, a commander in the LASD, have been met with a concerning silence, indicating a disheartening level of indifference and concealment within the department. This neglect challenges the LASD's commitment to accountability and transparency and starkly violates my rights and those of my child as protected under the Fourteenth Amendment to the U.S. Constitution. The Due Process Clause of this amendment is designed to protect individuals from unwarranted governmental actions that deprive them of life, liberty, or property without due process, including the fundamental right to maintain the parent-child relationship.

The LASD's actions, in this instance, egregiously breach my fundamental right to custody, care, and control of my child, amounting to undue interference in parent-child bond without due process - is in fact a violation of my U.S Constitutional rights.

Given the severity of these issues, I urgently request that the Los Angeles Sheriff Civilian Oversight Commission take decisive measures to address

this. The preservation of the integrity of our law enforcement institutions and the protection of citizens' rights are paramount. My complaint barely scratches the surface of the deeper issues within the LASD, rooted in my 20 years of exposure to discussions about the internal dynamics of LASD gangs.

I am confident that the Commission will handle this issue with the gravity it warrants, ensuring that the tenets of transparency, accountability, and civilian rights are upheld.
