The subpoena shall be made returnable at the Commission's hearing on March 20, 2025, at 9:00 a.m.

Proposed Motion No. 2: That the Chair be directed to issue a subpoenas *duces tecum* to the Custodian of Records of the LASD to produce the initial incident Force Review Report, related to former Deputy Sheriff Joseph Benza III's use of force against Emmett Brock. The subpoenas should be made returnable at the Commission's meeting scheduled for March 20, 2025. The subpoena shall be made returnable at the Commission's hearing on March 20, 2025, at 9:00 a.m.
