a) Department of Health Services – Integrated Correctional

- [ICHS Voice over Internet Protocol \(VoIP\) Migration and Phone Replacement](#) – \$103,000 to support the move from the LASD Call Manager to the DHS Call Manager, which would serve to upgrade the telecommunications infrastructure
- [ICHS Computer Upgrades for Mental Health Services](#) – \$343,000 to upgrade computers for security compliance for mental health staff
- [ICHS Operations / Space Renovations](#) – \$1,000,000 to renovate space to support the operational and infrastructure needs of increased staff and expansion of programs

- [Recovery-Oriented Permanent Housing](#) – \$2,200,000 to create housing units for recovery-oriented, low-barrier, abstinence-based permanent housing environment for justice-involved individuals who are in recovery from SUD and at risk of experiencing homelessness

- [Resentencing Project Continuity Funding](#) - \$4,167,000 for Post-Conviction Unit to fund legal services for individuals identify as eligible for resentencing pursuant to recent legislation
- [Paralegal Intern Program](#) - \$1,250,000 to fund paralegal interns to support Public Defender attorneys and paralegals with case management and legal administrative tasks


