I dialed 911 on July 11, 2003 and was hand cuffed arrested jailed convicted tormented degraded and academically disqualified socially ostricized and caste in the redlined district unincorporated area of South Los Angeles from my over 30 year tenure as a resident and working class civilian in SouhBay area after having spent longer than that investing my time effort and energy into improving the community by serving as a community service worker at the South Bay Mental Health Center and the Gardena Senior Daycare and the Juniperro Serra High School Parent Teacher Association as a tennis team coach who was born and raised in South Los Angeles as a youth as well as other metropolitan districts due to the nature of my being the product of divorce. It appears that the neighbors targeted me for search and seizure personal property theft and social distortions caused by forced entry home invasion robberies and car tire flats whenever I or my family traveled at Los Angeles International Airport over decades. I am now 10 years returned from the Southbay back to the core of African West migrants from the southern states and I am from a family from the North so that causes me to be a subject of insult and injury displacement and cutural wars for succedding and looking good while doing so smiling and passing out gifts because "folks don't like folk's being too proud and too free" as prophesized in this stage of my life by the film The Color Purple.

I went on the accomplish many goals make lots of impact and affect positive change in the community. My record can be found as a candidate for the best volunteer award at Gardena civic center where I hope to be memorialized for my loyal and excellent service over 30 years.

You can imagine the shock when I dialed 911 for help myself and was taken into a prison warehouse made to be publically humiliated and segregated forced family seperated and then denied the right to free speech and civil liberties by aggressions of harrassment and held up by forces of entitlement programs and welfare codes Health and Human Services and Department of the Public Social Services and The County Development Authority as well as Milestone Homeless Shelter after being a parent of a YWCA pre school graduate on Artesia where my daughter was hit in the mouth by a teacher's aide. The incident like many others over my entire life have been reported and witnessed so that the abuse of my person and inability of my spirit to enjoy the fruits of my labor and invest in the interest of my choosing have been deminished and most recently voter suppressed.

forces who recently confiscated my vehicle which is equipment essential for my commercial business Enterprisessss. I and my ancestors have treked the pedosphere for thousands of years and been acosted and displaced rejected and harmed as a whole from the tribes of West Africa since 1500 and from ancient Egypt of which is my throne quite naturally as I am remained sovereign after all these years indeed in mind body and soul despite disposition and title perspective and personal opinions regarding my operations and acquisitions holdings and investments here in what I refer to as Dizzyland.

Item 7 (C)	<p>I implore the COC to reconsider dissolving the Deputy Gang ad hoc. Claiming that, “the task that it was formed for was completed,” is not only shortsighted, but does not reflect where the COC’s community priorities should fall. As a resident of East Los Angeles I have seen first hand the violence and use of force of the East Los Angeles Sheriff’s Department.</p> <p>Furthermore, I have seen the continued blatant and shameful use of the ELASD’s racist deputy gang Fort Apache logo. When confronted about this logo Sheriff’s Deputies disregard concerns over the logo. Not only does the ELASD continue to use excessive force when “policing” our communities, but they continue to preserve the racist and violent history of their deputy gangs. Once again I urge the COC to reconsider dissolving the Deputy Gang ad hoc. 8(A)	<p>In future presentations on settlements, please allow the plaintiffs to provide their perspective. As displayed today, the Plaintiff’s has a The findings in the Rosas Panel’s Fifteenth Report, make clear that serious abuses inside the jail system are ongoing.</p> <p>The Report documents multiple incidents where deputies delivered impermissible head strikes, including one case where four deputies punched an incarcerated person ten times, six of those punches to the head. The Panel concluded these strikes violated Rosas. Yet at every level of review, LASD supervisors deemed the force “objectively reasonable,” and no meaningful accountability followed.</p> <p>In another case, video evidence showed a handcuffed, high-security inmate being escorted when a deputy gripped his neck and drove his head into a window ledge, causing serious head injuries. Despite video contradicting the deputy’s written report, LASD again failed to identify this as a Rosas violation. The report also describes force used against a detainee with mental illness wearing a suicide gown, where deputies claimed he was aggressive, but video showed him sitting calmly before deputies struck him in the face. Once again, LASD’s review cleared this use of force.</p> <p>These are not isolated mistakes. The Panel explicitly warns of a systemic failure to identify excessive force, misclassification of head strikes, and a breakdown in supervisory accountability. This failure directly undermines the purpose of the Rosas Settlement and puts incarcerated people at continued risk of serious harm.</p>	Ali Rubinfeld
