- A. Adopt National Association for Civilian Oversight of Law Enforcement's (NACOLE) Thirteen Principles for Effective Oversight of Law Enforcement
Action Item: Motion to formally adopt the NACOLE Thirteen Principles for Effective Oversight of Law Enforcement as guiding standards for the work of the Commission, which include: (1) Independence, (2) Clearly Defined and Adequate Jurisdiction and Authority, (3) Unfettered Access to Records and Facilities, (4) Access to Law Enforcement Executives and Internal Affairs Staff, (5) Full Cooperation, (6) Sustained Stakeholder Support, (7) Adequate Funding and Operational Resources, (8) Public Reporting and Transparency, (9) Policy and Patterns in Practice Analysis, (10) Community Outreach, (11) Community Involvement, (12) Confidentiality, Anonymity, and Protection from Retaliation, and (13) Procedural Justice and Legitimacy.

The Ad Hoc Committee’s primary purpose will be to share expertise on procedure and policy and to shed light on the courses of investigation, advice, and action by the Commission. This ad hoc committee is temporary and will be dissolved once the tasks are completed.

The Ad Hoc Committee’s primary purpose will be to monitor the LASD’s 2026-27 Fiscal Year budget operations, gather information, conduct analysis, and make on-going recommendations for consideration of approval by the Commission. The ad hoc committee’s second role will be to monitor the Commission’s budget and report back to the Commission with any findings and recommendations regarding the expenditures and necessary budget adjustments. The ad hoc committee’s third role will be to receive reports and recommendations about funding formulas in other jurisdictions. This ad hoc committee is temporary and will be dissolved once the tasks are completed.

Action Item: Motion that the Chair of the Commission form a newly titled “Deputy Gangs and Deputy Cliques” Ad Hoc Committee and select Commissioners of less than a quorum to serve on this committee.

The purpose of this ad hoc is to review policies and practices within LASD related to the existence of deputy gangs, cliques and subgroups within LASD – with focused attention on meet and confer of deputy cliques. The matter is related to a request/motion of the COC made on October 25, 2018, and the motion of the Board of Supervisors made on January 23, 2024 regarding the existence of Industry Indians within LASD. In addition, the ad hoc will work with the Office of the Inspector General, County Counsel and all relevant stakeholders to continue the comprehensive study of secret deputy subgroups, including the relevant

unions. This role is associated with a specific request/motion of the Board of Supervisors made on March 12, 2019, in Agenda Item 41-A.
