I am submitting this comment to request civilian oversight review of Los Angeles County Sheriff's Department practices as they intersect with juvenile dependency proceedings.

In my family's case, law enforcement involvement and subsequent referrals contributed to a child welfare detention based primarily on unconfirmed toxicology allegations, despite the absence of clinical symptoms and prior to adjudication. These actions have had profound consequences for a family without the benefit of fully validated evidence being tested in court.

I respectfully urge the Commission to examine whether current LASD referral practices, documentation standards, and reliance on preliminary or investigatory medical information adequately protect due process rights when families are referred into dependency systems.

Oversight is especially critical where law enforcement actions may influence child detention outcomes before judicial findings are made. Transparency, evidentiary rigor, and clear safeguards are essential to prevent irreversible harm to children and families.

ITEM 15 – NON-AGENDA PUBLIC COMMENTS

Just like this Commission is having issues with the  
LASD regarding Subpoenas Duces Tecum over Force  
Reports, I too have been having issues getting the  
LASD to comply with public records laws. I submitted  
a public records request in December 2025 for an up  
to date personnel roster for all publicly sworn in  
deputies. The LASD initially stated it would provide  
responsive records by January 12, 2026. That day  
passed and then the LASD sends an email now stating  
it will maybe have a newly updated reply by January  
15, 2026. I offered to compromise with the scope of  
the records I sought to help the agency process the  
responsive records in a reasonable timeframe as  
required by law. This good faith attempt was  
completely ignored. I worry that the LASD will simply  
continue shirking its ministerial duty and thus force  
me to seek judicial intervention in the form of a writ  
of mandate (or in the alternative declaratory  
injunctive relief). Judicial intervention is a final resort.  
Administrative relief is already well founded by the  
California Public Records Act, along with other  
relevant laws. I have no confidence the agency will  
operate in good faith but I will continue to patiently  
wait and accommodate the agency to exhaust all my  
administrative remedies, until such time that there  
are none.
