## **II. DISCUSSION AND ACTIONS**

6. Discussion and take appropriate action on the Los Angeles Probation Oversight Commission's bylaws and philosophy on public comment. (21-0839)

**No members of the public requested to comment on this item.**

**Ms. Julien introduced the Los Angeles Probation Oversight Commission's draft bylaws and opened the floor for discussion. Discussion ensued and Commissioners made recommendations to the draft bylaws.**

**Commissioner Saltzman suggested minor corrections noted in Chapter 2, Section 3; Chapter 8, Section 2f; and Chapter 8, Section 4d. He also suggested that the wording in Chapter 7, Section 1, be rewritten as "The membership of a subcommittee will not constitute a quorum of the full Commission," instead of "The membership of a subcommittee will never exceed a quorum of the full Commission." In addition, he suggested that in Chapter 8, Section 2e, the word "profane" be removed from the second line. Commissioner Garcia-Leys agreed with Commissioner Saltzman's suggestions.**

**Commissioner Nong referenced Chapter 2, Section 1, and highlighted that the commission should take proactive measures to ensure the public is aware of meeting schedules and suggested that the bylaws mention the use of a listserv; and suggested that the public be allowed to sign up on the commission website to be included in a listserv. Ms. Julien commented that there are two existing listservs, which will eventually be combined and used for sending invitations, agendas, meeting information and basic communication. She also mentioned that the process has already begun to allow members of the public to sign up for the listserv on the Los Angeles Probation Oversight Commission's website: poc.lacounty.gov. In response, Commissioner Nong suggested that the wording in the last line in Chapter 2, Section 1, should read "...which schedule shall be posted on the Commission's website and distributed to the public through any listservs or other mediums designed for public notice."**

**Commissioner Nong referenced Chapter 8, Section 1, and suggested there should be more options for members of the public who want to address the commission on a particular agenda item or during the public comment section of the agenda and that the word "written" should be removed. She also asked that the language be added to this section to explain that comments in a language other than English should be allowed double the allotted time to account for translation.**

**Alexandra Zuiderweg, County Counsel, addressed the Commission and suggested that additional options for how to address the Commission can be included in the meeting agendas.**

**Commissioner Dupuy added that the Commission should consider referencing in the bylaws how and where meetings will be held and how information will be shared. Commissioner Dupuy also added concern for members of the public who call in because they may not have the technology to join via a computer; and, are therefore unable to make public comment. She offered that the Commission should consider available options to optimize public comment and input in a virtual environment.**

**On motion of Commissioner Jackson, seconded by Commissioner Saltzman, and duly carried by the following vote, the Los Angeles Probation Oversight Commission approved to table the bylaws to the next meeting pending a review of the recommended amendments:**
