Present: Commander Hugo Macias and Sargent Roger Short

Commander Macias shared that Sheriff Luna appointed Eileen Decker as the Director of Constitutional Policing. And that Sheriff Robert Luna supports good policing and is going to hold bad policing accountable. And will ensure accountability at all levels. As far as compliance consent decrees the idea is to work with the monitors to meet objectives. And overall would like to have overall continuity. And why he found it necessary to create the Office of Constitutional Policing. Commander Macias will follow up with the number of sworn and non-sworn personnel assigned to each facility. He stated that they are working on creating a facility in the communities to create capacity. And that some people will not qualify for diversion. He shared how they track use of force and process, investigations. And that although they track force the goal is to move into the 21st century technology so that they can run reports and have access to information, reduce manual labor, meet several objectives, and serve a number of shareholders. Commander Macias spoke to facilities director who reassured him that they have water audits and testing and that the results did not show any unordinary levels. And stated that facilities do not test the water themselves, they contract out and that the director of facilities is the subject matter expert. And Commander Macias will assist in getting the water test results.

Commander Macias stated that they he will be meeting with the Commander and Captain at CRDF to address your questions. And addressed the concern at Twin Towers in which fecal matter was on the walls. And contract Internal Services and Servicon to increase the cleaning frequency in areas for the 60 licensed beds. In regard to MCJ, they have weekly meetings to ensure that individuals do not prolong their wait and get interim housing in an appropriate space to account for needed services. And MOSH refers to Medical Outpatient Specialty Housing. Commander Macias to report back to the SBC on when the 171 matter was cleaned, and how long it took to clean. Lastly, Commander Macias shared that they follow medical's lead in regard to moving patients and are at their notice, but due to lack of space there are delays.

- **3.** Department of Health Services and Mental Health Services in the Jails and Lock up facilities (Dr. Timothy Belavich). (23-1071)
  - Twin Towers and MCJ: Rated Capacity vs. Current Occupancy
  - Treatment standards average wait time for psychiatrist (# of days by acuity level and by facility)
  - Vacancies: Current vacancy rate and effect on access to care

Dr. Belavich stated that he will be forwarding the total 2022 death count to the SBC. And reported administering over 480 Sublocade injections and 2,200 patients received Suboxone while being treated with Medical Assisted Therapy, MAT. COVID numbers are updated daily and available on the LASD website: https://lasd.org/covid19updates/. Currently there are 56 in isolation, 42 confirmed and 14 Persons of Interest (PUI's). 971 are quarantined across facilities. And turned to the LASD to answer Rated Capacity vs Current Occupancy. He reported that ORCHID does not track psychiatric wait times. And vacancy numbers reported at the last meeting by Ms. Joan Hubble, DMH have not changed. Commander Macias stated that they have a rate of capacity, which is there recommended operational capacity, as well as a facility capacity which is well below 96. Dr. Belavich stated that DHS set a limit of 80 capacity. Commander Macias stated that there is no standard capacity, and that capacity is based on service, and therefore every facility has a different rating. He briefly discussed the current jail management process and their desired jail management system. And agreed to have someone from the Population Management Bureau, PMB present their process with the SBC. Dr. Belavich stated that frequencies in which people should be seen is every 30 and 90 days. And that they look at data to see how they did but are working on getting a scheduling system. He reported that they do not set the number of patients should be seen due to labor negotiations but do have that recommendations. Lastly, he briefly discussed accreditation.

Mr. Erick Montalban, COC stated held its special hearing on Deputy Gang's on March 3, 2023, in which they discussed the reports from special counsel. And adopted the 27 recommendations that were listed in the report. Also, that a supplementary report will be produced to include comments and recommendations from the community. And that the board of supervisors approved Supervisor's Solis's motion to support the COCs recommendations to eradicate deputy gangs. He also shared that the COC will be holding town hall meetings in April. And will visit each of the supervisorial districts to get input. And that Council has already started talking to community members. And that the COC is in the process of setting a permanent location to host their meetings. And reminded everyone that the COC is meeting tomorrow. Lastly, he announced that the COC is seeking an executive director.
